WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Environmental Protection Commission was created and authorized by Title 27 Section 101 of the Cherokee Nation Code Annotated (CNCA);


WHEREAS, the Principal Chief is authorized to appoint members of the Commission subject to majority vote of the Council of the Cherokee Nation; and

Blake Fletcher is hereby reappointed as a Commissioner of the Cherokee Nation Environmental Protection Commission, Seat #5, for the term of April 1, 2015 expiring March 31, 2018, as authorized by Title 27 Section 101 (B) of the Cherokee Nation Code Annotated (CNCA).


CERTIFICATION


