

Cherokee Nation Gaming Commission Director's Report 26 JUNE 2013

Gaming Commission

- CNGC staff met with the CNE Employee Services Department to go over the proposed changes to Sections 13 & 15 of the CNGC Tribal Internal Control Standards. Revised comments were submitted as a result of the discussion and appear as an agenda item this month.
- ∞ CNGC staff attended the Cherokee Nation legislative day held at the State Capitol in Oklahoma City. Information about the Gaming Commission as well as other Cherokee Nation departments was provided to Oklahoma legislators and to visitors to the Capitol.
- CNGC and CNE staff met with staff from the NIGC to discuss the NIGC fee calculation worksheets. The NIGC wanted to discuss the process for completing the worksheets, which they felt led to errors in the last submission. The process was clarified and the errors that were found were in CNE's favor. The worksheets will be recalculated and a credit is expected to be applied to the next quarterly payment in June.

to: two (2) new/pending positions, three (3) vacancies due to turnover, and two (2) staff on intermittent/full time medical leave. Audit's staffing level was set at twelve (12) resources required to complete the approved FY 2013 Audit Plan.

- Other Audit projects pending include follow-up procedures for the Complimentary Audit for Hard Rock and Player Tracking Audits for all locations due to management disagreements and/or significant non- compliance issues. The 2014 Audit Plan/Cycle will be presented at the June meeting to cover July 1, 2013 through June 20, 2014.
- The online license application agreement was signed by the Cherokee
 Nation Purchasing department this week. A meeting has been scheduled
 with HotLink HR (service provider) for May 30th to start the implementation
 process.
- ∞ The new CNGC licensing regulation and fee structure went into place on May 1st and no issues so far.
- The Licensing Department will be conducting a licensing audit at each
 property within the next few weeks to make sure that everyone has a license
 along with correct information on it.
- Privacy Act notices and False Statement notices are going out to employees to be signed during this renewal cycle in order to comply with the revised NIGC regulations.
- ∞ Kelly Myers, Licensing Manager, was appointed as the OTGRA Vendor Licensing committee Chairman and did presentations on vendor and employee licensing at the OTGRA conference.

Cherokee Nation Entertainment

 ∞ No significant events to report.

National Indian Gaming Commission

∞ Dan Little, Associate Commissioner, was reappointed for another three (3) year term. The position of Vice-Chair remains open. Chairperson Stevens' term is set to expire next month.

∞ The National Tribal Gaming Commissioners/Regulators has set the date and location for the Fall Conference: September 17th – 19th at the Harrah's Cherokee Casino in Cherokee, North Carolina.
