CALL TO ORDER

Co-Chair Taylor called the meeting to order at 3:36 p.m.

INVOCATION

Councilor Walkingstick gave the invocation.

ROLL CALL

APPROVAL OF MINUTES

Councilor Baker moved to approve the September 25th regular session and the September 25th PAC Sub minutes as submitted. Councilor Vazquez seconded the motion. The motion carried.

REPORTS:

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn announced they received a GFOA award for their popular annual financial report or condensed report for the second year in a row. They also received the GFOA award for the comprehensive annual budget report for the thirteenth straight year. She offered to answer questions from the report provided. Chair Taylor gave appreciation the various grants obtained.

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton reported on the August results. He provided an update on the current

projects including the Roland casino, South Coffeyville casino, remodel of the original hotel at Catoosa, and the clinics. Councilor Vazquez gave appreciation for the extraordinary art market recently held. Councilor Baker inquired about a completion date for the Cherokee Plaza here in Tahlequah. Councilor Cowan Watts requested clarification on the flood rating for the Cherokee Plaza land. Mr. Slaton provided clarification on the outlet location situation.

Career Services/Employment - Diane Kelley

Ms. Kelley gave an update on the new office locations and ribbon cuttings. She announced there will be a construction fair for the Cooweescoowee Clinic on November 13th, for the Jay Clinic on November 18th and for the Mankiller clinic on the 20th of November. She commented they are working with Mr. Slaton and CNB on several projects. They are looking into the possibility of putting signage up at the construction sites to direct people on where and how to apply for jobs. The JDNEG Group is meeting in Siloam Springs today for training. They are enhancing their service delivery with the new office openings and have been notified there will be office space available in the new Ochelata clinic. She stated they are in preparations for the big TERO banquet next Thursday. She provided a report as requested on the Re-Entry Program. She offered to answer questions from the reports provided.

Commerce - Anna Knight

Ms. Knight offered to answer questions from the report provided. She commented she included several power point slides from Deidre Myers with the Oklahoma Department of Commerce that were part of her presentation at the summit. She commented they are expecting 125 vendors at the TERO vendor fair coming up.

Mr. Reece announced a new list has been provided and noted it would be after the first of the calendar year before the new funds are available. Councilor Keener moved to approve. Councilor Garvin seconded the motion. The motion carried.

SPORTS TEAMS APPLICATIONS

Councilor Byrd moved to approve the list provided. Councilor Keener seconded the motion. Councilor Glory Jordan suggested reviewing the policy in regard to one person applying multiple teams. She offered a friendly amendment to hold the two applications submitted by the same person until next month. The friendly was accepted. A requested was made for an additional column on the spread sheet stating the type of sport. Councilor Glory Jordan suggested adding the Councilor's signature for approval of applications in their districts. The motion carried.
