**A RESOLUTION AUTHORIZING CHEROKEE NATION WAREHOUSE
TO DONATE SURPLUS OFFICE EQUIPMENT TO FRIENDS OF THE
LIBRARY IN DELAWARE COUNTY**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following office equipment in its inventory that has been deemed surplus:

Emergency Vehicle Lights, Lot 8 – CN # N/A
15 Tables, Lot 24 – CN # N/A

WHEREAS, the Cherokee Nation Warehouse desires to donate this office equipment in “as- is” condition.






