AMEND THE AGENDA

Councilor Cobb moved to amend the agenda to include items 12 and 13 on the agenda passed out of committees earlier today; from Health Committee a resolution authorizing an application to the CDC for a public prevention health fund grant and from the Education & Culture Committee a resolution authorizing an application for a head start replacement grant. Councilor Thornton seconded the motion. The motion carried.

APPROVAL OF MINUTES OF PREVIOUS MEETINGS

Councilor Jack D. Baker moved to approve the May 16th regular session minutes. Councilor Garvin seconded the motion. The motion carried.

LEADERSHIP PROGRAM PARTICIPANT INTRODUCTIONS

Mr. George Roach gave an overview of the Summer Youth Leadership Program stating it is a six week paid internship program where you must be Cherokee, have a 3.0 grade point average and live within the fourteen county boundaries. He requested the eleven participants to introduce themselves.

STATE OF THE NATION

Chad Smith Principal Chief

> Principal Chief Chad Smith requested a moment of silence for those Cherokee friends and family who we have lost over the last month. The veterans honored for the month were Chester Kelley, Carl Ralston, Joe Watt and father and son Jerry and Virgil Davis. In program and service updates he announced the Cherokee Nation will receive \$3.7ml from the BIA to update our land title records. The NAHASDA funding will increase by \$3.9ml due to the final allocation of housing funds. The Cherokee Nation broke ground on a new expanded casino at Ft. Gibson. In West Siloam a satellite office was opened to allow Cherokees to access the Cherokee Nation employment and vocational resources. The central mail order pharmacy was opened in Muskogee. The general election is this Saturday with early voting opportunities in the Election Commission office from 8:00 a.m. to 5:00 p.m. on Tuesday through Thursday. He announced the Cherokee Nation Marshal Service, Emergency Management, Career Services, Talking Leave Job Corp and Cherokee Nation Entertainment responded to the areas recently hit by the devastating tornados. The Cherokee Nation also served as a collection point to drop off supplies for the tornado victims. The riders from the Remember the Removal Project will return home this Friday with a welcome home event scheduled at 10:30 at the Court House Square. He stated tonight on the agenda is something historical and of great governmental value. This is an opportunity to correct a blemish on the laws of the Cherokee Nation. These two laws passed in 1997 were passed without a quorum present and found unconstitutional by the Courts. Councilors Cowan Watts and Anglen presented Chief Smith with a baseball signed by Cherokee citizen Dylan Bundy who was just drafted by the Baltimore Orioles.

Monthly Reports:

Housing Authority - David Southerland

Mr. Southerland announced a board meeting is scheduled on June 28th at noon with a lengthy agenda. He stated he looks forward to working with the two new board members once confirmed this evening. He gave thanks and appreciation to the two former board members Wayne Dunham and Ken Limore. They received notification they are not eligible for the Cookson Hill Community Action FEMA trailers. Mr. Southerland stated they are looking forward to the implementation of a portion of their

new financial software in August of this year.

Cherokee Nation Business, Inc - David Stewart

Mr. Stewart reported financially the company is doing very well with results approximately 7% over last year. They are slightly behind budget year to date from last year net income. The line of credit has been paid off therefore they have no long term debt. The jobs well done initiative is alive and well with 95% of the new hires over the last sixty days being Cherokee. They are in the design phase of all of the different properties and will provide renderings to view once complete. The Jay laundry is moving along slow as they have to remodel the building purchased. Councilor Thornton requested a report regarding the hydroelectric plant be provided at the next committee meeting. Councilor Cowan Watts commended Mr. Stewart on the article in the Cherokee Phoenix regarding economic development. Speaker Frailey stated she has received a lot of positive feedback on the Jay laundry.

Councilor Coates commented this is a critical time in our history and should be reflected properly. She referred to creating a record within LegiStar for void ab initio to provide this accurate understanding. Councilor Glory-Jordan stated she is in opposition of this legislation due to the method in which it is being done as it has already being corrected in the courts. |
