## COUNCIL OF THE CHEROKEE NATION

# A RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE U.S. DEPARTMENT OF JUSTICE UNDER THE COORDINATED TRIBAL ASSISTANCE SOLICITATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self government in behalf of the Cherokee people; and

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United Sates of American; and

WHEREAS, the U.S. Department of Justice has initiated a consolidated grant application process for tribes that provides for application for up to ten discrete programs in one package designated as the Coordinated Tribal Assistance Solicitation 2010; and,

WHEREAS, the Cherokee Nation has identified program service gaps and needs that might be addressed by programs under this process; and,

WHEREAS, such needs are addressed through the Methamphetamine Reduction Program under COPS and the Justice Systems and Alcohol and Substance Abuse Program within BJA;

WHEREAS, such programs total amounts of \$199,041 for Methamphetamine and \$500,000 for Alcohol and Substance Abuse such other amount as may be negotiated resultant to application and review; and

WHEREAS, it is in the best interests of tribal citizens to provide such services and protection.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the Tribal Council approves the submission to DOJ and accepts the above listed amounts or any other amount that may be subsequently awarded in the negotiation process.

# **NARRATIVE:**

The Cherokee Nation applied for several programs from the Department of Justice under a consolidated grant application process. Two of the programs have tentatively been awarded two grants: Drug and Alcohol, and Methamphetamine Enforcement. Both programs require a resolution accepting the programs prior to draw downs, and within ninety days of their selection. The slow process for grant award will already result in an implementation lag. It is critical that the draw downs begin as soon as possible to insure appropriate completion of the work plans.

The Drug and Alcohol Program will set up an outpatient treatment program for juveniles who are in the tribe's drug court program. Behavioral Health does not presently have the ability to respond to the Drug Court needs under its present service system.

The Methamphetamine program will follow up on tribal intelligence about drug cartel movement and business within the tribe's jurisdiction to work cooperatively with other tribes along the drug corridors in Indian country in eradicating shipment and sale.

The amounts listed in the resolution are the exact amounts that will are awarded. Since the programs were in one consolidated application, only one resolution is needed.
