REPORTS:

1. Management Resources - Bruce Davis

Mr. Davis recognized Taylor Alsney and his staff for their outstanding work to get the Cherokee Holiday events ready. Councilor Fishinghawk inquired if all of our community buildings are now insured. A motion was made by Councilor David Walkingstick, seconded by Councilor Lee Keener Jr., that this matter be Approved and Forwarded to Council to the TRIBAL COUNCIL due back on 9/15/2014. The motion carried unaimously by Voice Vote
