The Cherokee Nation Marshal Service desires to donate these items in "as-is" condition.

### Three (3) Armor Express Patrol Vests

**WHEREAS** the Gore Police Department, located within the Cherokee Nation's jurisdictional boundaries, operates on limited funds, and donating said items would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION** that the Tribal Council authorizes Cherokee Nation Marshal Service to donate these surplus items to Gore Police Department as set out above.
