Councilor Taylor moved to approve the October 17th regular session minutes. Councilor Baker seconded the motion. The motion carried.

STATE OF THE NATION

Deputy Chief Crittenden gave the State of the Nation in the absence of Chief Baker. Deputy Chief Crittenden announced Chief Baker is traveling to Standing Rock to support them in their fight to protect water and ensure their natural resources remain in tack. This is the Nation's second trip to deliver wood and water. We have secured ownership of Sequoyah's Cabin from the State Historical Society. We are celebrating the one year anniversary of our grant and partnership with the CDC to screen and cure Hepatitis C. We hosted the Annual Native American Contractors Association Conference at the Hard Rock. Deputy Chief Crittenden recognized the newly elected Tribal Youth Council in attendance. The President of the Tribal Youth Council, Austin Jones, gave an update of Youth Council's recent activities. Deputy Chief Crittenden

read a long list of Cherokee citizens who have passed away within the last month. He requested a moment of silence for them.

COMMITTEE REPORTS

Monthly Reports:

Housing Authority - Gary Cooper

Mr. Cooper announced the next board meeting is on the same day as their employee staff development on the 20th of January. This week the Housing Rehab department is moving office locations here in town. He reported we provide housing assistance to 6,949 families monthly as of September. As of the end of September the Housing Authority had 251 employees with 95.2% of those being Cherokee and 98.4% total Native American employment.

Cherokee Nation Business, LLC - Shawn Slaton

Mr. Slaton reported on the end of the fiscal year totals. Our gaming operations remain strong even with a new competitor in the market. Our diversified businesses were a huge part of our success by accounting for almost \$400ml in revenue and record profit. Our diversified businesses were awarded their first overseas contract with the State Department. He provided an update on the current projects including the Spa at Hard Rock and the new Grove casino. Our Cherokee Nation Technology Group is providing unmanned aircraft to help NASA with meteorological forecasts and storms. CNB currently has 6,586 employees, 4,647 of which preference can be practiced and of those 73% are Cherokee, other Native Americans are at 7.1% for a total Native American employment of 80.2%. He offered to answer questions from the report provided. Speaker Byrd recognized CNB Board member Jerry Holderby in attendance.
