Just prior to the new year the opportunity zone programs were launched, these loan programs makes up look at the high poverty tracts from the census. The Heirloom Seed Bank Program was recently launched for the year and will close on February 13th. The Harvesting our Heritage Program is the heirloom seed program for Cultural and Community Organizations. Military branch specific veteran license plates will be launched this year. It is Human Trafficking Awareness Month, an event was held to declare this and*

We recently hosted the quarterly Inter-Tribal Council at the Hard Rock where a number of resolutions passed with the common theme of Native Americans being at the table when it comes to policy making. Another item for consideration this evening is to expand the vision of what we are doing in the area of substance abuse disorder with the opening of both out-patient and in-patient centers in Vinita and Tahlequah.*
