# MIINUTES OF TRIBAL COUNCIL MEETING – REGULAR SESSION MONDAY, SEPTEMBER 10, 2007

### **CALL TO ORDER:**

Speaker Frailey called the meeting to order at 6:00 p.m. in the Tribal Council Chambers, W.W. Keeler Complex.

### **INVOCATION:**

Councilor Crittenden gave the invocation.

### APPROVAL OF MINUTES OF PREVIOUS MEETING:

Councilor Anglen moved to approve the minutes of the August 13<sup>th</sup> Regular Session. Councilor Bill John Baker seconded the motion. Motion carried.

Councilor Bill John Baker moved to amend the agenda to add as item #19, the FY 2008 budget to allow the Council to approve the budget at a reconvened council meeting. Councilor Cowan Watts seconded the motion. Motion passed.

Councilor Bill John Baker moved to withdraw item #4 which was tabled in committee. Councilor Garvin seconded the motion. Motion passed.

### STATE OF THE NATION ADDRESS:

Chief Smith expressed his personal appreciation to all employees and other volunteers who the Cherokee Holiday a wonderful experience for all visitors and the Cherokee people. He requested a moment of silence to pay respect to members and friends who have passed this last month. Veterans honored this month were Charles Bud Carey and Sammy James Carey. Applications are currently being taken for the Cherokee Nation Tribal Youth Council for member districts 5-7. Interested persons may contact Reba Bruner for the application and the deadline is September 21<sup>st</sup>, 2007. Congressman Watson from North Carolina introduced an amendment to the NAHASDA authorization bill that would remove Cherokee Nation housing funds because he disagrees with the constitutional amendment that the Cherokees passed on May 3<sup>rd</sup> stating that we should remain as an Indian Tribe made up of Indians. This issue is currently before three

separate courts. Congressman Dan Boren introduced another amendment which assures continued housing funding for the Cherokee people while the case is pending in tribal court. He introduced the nominees for cabinet and Supreme Court appointments. Kathy Sierra received her master's level in the Cherokee Language.

### **MONTHLY REPORTS:**

### Housing Authority: David Southerland

David Southerland announced the HACN Board meeting has been rescheduled to September 12, 2007 at 5:30 p.m. in the Alyene Hogner conference room. The Community Shield Program is a home ownership coverage program that provides up to \$80,000 replacement cost coverage on the dwelling and \$10,000 personal property coverage and they have just under 2200 families on the program. They currently have 2000 families on the Home Ownership Program and these are homes that were developed through mutual help. They have 923 rental units and 90% are occupied. They have 170 employees of which are 97% Native American.

### Cherokee Nation Enterprises: Shaun Slaten

Shaun Slaten reported the month of July 2007 had a 20% increase compared to July of last year. He gave brief updates on the Cherokee Holiday activities and the expansion projects. They currently have 3200 employees with 71% being Native American and 51% are Cherokee.

#### Cherokee Nation Industries: Dennis McLemore

Dennis McLemore reported they are transitioning their year end of June 30<sup>th</sup> to September 30, 2007 to match Cherokee Nation and the other tribal entities. He reported \$9.3 million in sales. They are currently remodeling the old Wal-Mart and will be moving some of the manufacturing over to the building. They have 230 employees with 90% Native American. The next board meeting is scheduled for September 24<sup>th</sup> at 3:00 p.m. with the location to be announced at a later date.

### Cherokee Nation Businesses, Inc: Brad Carson

Brad Carson reported they are now the sole share holders of CNE and CNI and soon to be the sole share holder of debit companies affiliated with Cherokee Nation Industries such as Cherokee Nation Distributors and Cherokee Nation Medical Services. They provide seven shared services and do so effectively and efficiently. They will provide about \$4 million dollars of shared services to CNE and half a million dollars to CNI. In addition to providing the shared services they are responsible for diversification and capital allocation. The bulk of their employees are Native American. They have 47 authorized positions with 46 of those currently filled and approximately two-thirds of those are Cherokee.

Councilor Snell moved for approval from the Council to approve items 1, 2, and 3 in Toto as they are grant applications to the EPA. Councilor Bill John Baker seconded the motion. There were no objections. Motion passed.

# A Resolution Confirming the Renomination of Robert Jenkins as a Commissioner of the Cherokee Nation Tax Commission/R#79-07

Councilor Cowan Watts moved for approval of the renomination. Councilor Anglen seconded the motion. Motion passed with opposition from Councilor Glory-Jordan and Fishinghawk.

# A Resolution Confirming the Renomination of Mark Fredrick as a Member of the Cherokee Nation Environmental Protection Commission/R#80-07

Councilor Garvin moved for approval of the appointment. Councilor Cowan Watts seconded the motion. Motion passed.

# A Legislative Act Defining Nepotism, and Defining Acceptable Parameters for Employment and Contracting and Amending Title 28, "Ethics", Adding New Sections, and Repealing Certain Sections of the Cherokee Nation Code Annotated/LA#34-07

Councilor Cobb stated the purpose of this Act is to codify the issues relating to conflicts of interest pertaining to employees and appointed and elected officials of the Cherokee Nation; use businesses owned wholly or partially by Cherokee Nation employees and appointed and elected officials; employment of relatives of elected officials, including the prohibition of nepotism; and the parameters under which Cherokee Nation employees and officials must operate with respect to conflicts of interest. Councilor Cobb moved for approval of the Legislative Act. Councilor Cowan Watts seconded the motion. Councilor Jack Baker offered a friendly amendment in Title 28, section 3; paragraph F, to strike Cherokee National Historical Society, Inc. because it is not an owned entity of the Cherokee Nation. Also in paragraph J, strike Cherokee Heritage Center because it is ran by the Cherokee National Historical Society. Councilor Cobb accepted the friendly amendments. Roll call is as follows:

Councilor Jack Baker stated mod 11 increases the budget by \$2,079, 294. He offered an amendment to add an additional \$50,000 for the Vocational Education students and this would increase the budget by an additional \$50,000. Councilor Jack Baker moved for approval of Mod. 11 with the amendment. Councilor Cowan Watts seconded the motion. Roll call is as follows:
