**COUNCIL OF THE CHEROKEE NATION**

**A RESOLUTION CONFIRMING THE REAPPOINTMENT OF CLARICE DOYLE AS A  
COUNCIL APPOINTMENT TO A BOARD SEAT  
AS AN EDITORIAL BOARD MEMBER OF THE CHEROKEE PHOENIX**

**WHEREAS**, the Cherokee Nation, since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee People; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

**WHEREAS**, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 19-00 and amended by Legislative Act 15-25;

**WHEREAS**, Clarice Doyle is reappointed by the Council of the Cherokee Nation to serve a term as Editorial Board Member of the Cherokee Phoenix effective November 10, 2025 through November 30, 2031, as authorized by Legislative Act 15-25;

**WHEREAS**, Clarice Doyle is duly qualified to fill this position pursuant to the laws of the Cherokee Nation.


**BE IT RESOLVED BY THE COUNCIL OF THE CHEROKEE NATION** that Clarice Doyle is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a term effective November 10, 2025 through November 30, 2031 as authorized by Legislative Act 15-25.


