

#### **Initiatives** c.

Career Services has started the process of converting the Career Services Resource Room to the Career Services Assessment Room to become compliant with the Oklahoma State Department of Education's requirements for the

- upgraded GED Testing System. The project should be completed within the next month and will include some minor remodeling including the addition of a glass wall as well as the acquisition of some new computers and secure locker storage. The new system will be completely computer based and will allow us to streamline processes while serving more clients in their assessment endeavors.
- 2. The Nursing Program has been working since February with John Gritts who is with the U.S Department of Education's Federal Student Aid Department to find out what steps are to be taken in order to help the students in our Surg. Tech Program become eligible for Federal Student Aid. Our long-term goal is for the program to become an accredited institution that is eligible to participate in the Federal Student Aid programs; however, there are certain conditions to be met and we're being told that it could take several years before this becomes a reality. In the meantime, Mr. Gritts will also help us explore the possibility of this program partnering with the same medical school that Hastings Hospital partners with and if this works, the surg. tech program would be able to use their school code for Title IV funding while awaiting eligibility.

Outreach presentations on stick ball, pottery, basket weaving, blow guns and darts were given to 449 students from 8 schools in the 14 county area.

#### Archives:

ODL Recognition: Tom Mooney and Cheryl Parrish represented Cherokee Nation and the Heritage Center at the state capitol at the Oklahoma Department of Library's Cultural Heritage Trust conference. The Cherokee Land patent, issued by President Van Buren granting 7 million acres to the Cherokee people has been nominated as one of the state's most endangered artifacts and is competing with 9 others for the top honor.
