WHEREAS, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 11-00;

WHEREAS, Rob Thompson is nominated by the Principal Chief to serve a six-year term as an Editorial Board Member of the Cherokee Phoenix from March, 2010 through March 2016, as authorized by Legislative Act 11-00; and

WHEREAS, Rob Thompson is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Rob Thompson is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a six-year term effective March, 2010 through March, 2016 as authorized by Legislative Act 11-00, the Act of July 17, 2000.
