# **Program Highlights for April 2013**

I. Indian Child Welfare Child Protective Services (CPS): There were 229 referrals of Cherokee child maltreatment from 27 Oklahoma Counties and 0 out of state. In April, there were a total of: 82 referrals for neglect only, 80 referrals for physical abuse, 84 substance abuse, and 67 referrals for sexual abuse.

- a. ICW Court Advocacy and Permanency (CAPS) Units: There are 1439 Cherokee children with assigned ICW workers. ICW workers were involved in 238 hearings regarding these children in April.
- b. **ICW for Guardianships and Private Adoptions:** There were 5 placements made in April. This last month we had 3 new homes open up as well as 5 homes close and 9 get recertified. There were a total of 35 children unable to be placed in April.
- c. **ICW Family Protection Services:** We have 58 children receiving services and 25 adults. This is a new program offering prevention and parenting services to families in the court system to assist in reunification with the children.
- d. **John Ketcher Youth Shelter:** 20 youth spent time at the John Ketcher Youth Shelter this last month.
  - i. **Juvenile first time offender program:** There were a total of 4 participants, 7 referrals, and 2 successful completions. We had 12 community service hours this month and 2 volunteers.
- e. **ICW Family & Employee Development:** We had 5 trainings with 31 attendees and 0 staff trainings during the month.
- 2. Child Support Services: The distribution for April was \$221,300. Child Supports Year-to-Date economic impact on our community is \$1,468,961. This is a \$29,846 increase from April 2012. There are a total of 2,704 child support cases and there are an additional 1440 that are either in transfer, new application status or are inactive status that our office must review on a daily basis. There were over 1400 contacts made with citizens needing assistance on their child support cases. As of this month we are planning our annual Clothing Voucher Programs details and will be sending out an all employee email of the destinations and dates in July.
- 3. Family Assistance (Food Distribution): There were 8,652 individuals served in April. Year-to-Date Individuals Served: 64,292 throughout the 14 county jurisdictional boundaries.
  - a. **Family Assistance (Elderly Nutrition):** There were 4,726 hot meals served at Elderly Nutrition Sites and 1,249 Elder Nutrition Home Deliveries in April. Year-to-Date: Hot Meals Served 4,726; Year-to-Date: Home Deliveries: 1,249. \*\*\*This programs year begins in April.

- b. Family Assistance (LIHEAP): There were 3 households served for Heating Assistance, and 172 households served for Winter/Summer Crisis during the month of April. LIHEAP YTD Served of all types; 2,627.
- c. Family Assistance (NAHASDA): There were a total of 184 Transitional, 48 Residential, and 14 Elderly households served this month within the NAHASDA Program and we have served 1,666 YTD households served.
- d. Family Assistance (General & Burial Assistance): 263 individuals were helped within General Assistance and YTD 1,795 has been served through this program. There were 40 Families helped within Burial Assistance in April and Year-to-Date we have assisted 266 families.
- e. **Elders in Need Program:** This program has been designed for our elders age 60 and older on fixed incomes who are in need of assistance. In the month of April we served a total of 33 Elders in our 14 county jurisdictions and YTD we have served 1,255 households which is 100% of our annual projection.
- f. **Elder Advocacy Program:** In the month of April we were able to serve 28 of our Elders with this program. Our YTD Elders In Need served is 137.
- 4. Child Care & Development (Child Care Centers): The Child Care Development Center is rated three stars, the highest possible in Oklahoma. There are a total of 133 children attending our Child Care Development Centers and there are 6 vacancies.
  - a. **CC&D** (Subsidy): 1869 Children received subsidy in April 2013 for the entire Cherokee Nation jurisdiction and over \$295,681.95 was distributed last month alone.
  - b. **CC&D** (Resource & Referral): There were 2191 information calls received, 29 parent calls for referrals, 13 community events, 35 home visits for technical assistance, and 83 children receiving home visits. There were 3 trainings held in April.
  - c. **CC&D** (Licensing & Monitoring): Visits Made in April: 28 with a relative provider, 17 with child care centers, and 17 in child care homes.

## 5. Special Programs -

- a. Office of Veterans Affairs: The Tribal Veteran's Representative received 25 calls for information and made 100 in person visits with Veterans in April. To insure we have a representative to assist the Veterans, the Veteran Affairs Office has increased their visits to our office until we can fill the vacancy of our Tribal Veterans Advocate. In May, Trina Fisher and John Cloud will be here every Tuesday (7<sup>th</sup>, 14<sup>th</sup>, 21<sup>st</sup>, and 28th) to assist with the Veterans Office. Matt Tiger is here various times throughout the week and is reachable by phone (822-2563), if needed.
- b. Healing to Wellness Court Program: There were 16 youth participating in the voluntary Reclaiming Futures and Healing to Wellness Court Programs. There were 62 home visits with or about clients and 8 home visits concerning referrals in April. There were 20 drug tests administered, 10 calls for resource information and 40 contacts regarding participant treatments this month.

c. **Bright Futures (Truancy Prevention):** The Bright Futures program had 19 new cases worked in the month of April. We had 0 referrals to the program last month and there were 15 additional families agree to services.

## Youth Development

# Youth Activities: Total attendance at April youth activities was 244 youth, 21 parents/community members/B&G Club staff & 4 CYD staff.

- Cherokee Heights had 5 youth activities in April the 2<sup>nd</sup>, 9<sup>th</sup>, 16<sup>th</sup>, 23<sup>rd</sup> & 30<sup>th</sup>; where they made baskets, key chains, played Cherokee Marbles, made recycled bracelets and had a drug free Movie day and the teenage youth worked on peyote stitch beaded key chains. There were from 9-17 youth at each meeting for a total of 76 youth, 3 parents, & 4 CYD staff in attendance.
- Greasy had a youth activity scheduled for Thursday, April 11<sup>th</sup>, we went to Greasy but no youth showed up. There were 4 CYD staff who showed up.
- Lost City had one youth activity on Thursday, April 18<sup>th</sup>, where they made clay pinch pots and had 15 youth, 5 parents/community members and 4 CYD staff in attendance.
- Tailholt had one youth activity on Monday, April 22<sup>nd</sup>, where they made melted pony bead sun catchers and had 15 youth, 3 parents/community members and 4 CYD staff in attendance.
- Keys Boys & Girls club hosted a youth activity on Monday, April 1<sup>st</sup> where kindergarten, 1<sup>st</sup> & 2<sup>nd</sup> grade made key chains, there were 17 youth, 2 club staff and 4 CYD staff in attendance.
- Marryetta Boys & Girls club hosted a community youth event on Monday, April 8<sup>th</sup>, where the youth made leather pouches. There were 27 youth, 1 B&G club staff members and 4 CYD staff members in attendance.
- Cave Springs Boys & Girls club hosted a community youth event on April 15<sup>th</sup>, where the youth made leather pouches. There were 9 youth, 1 B&G club staff member and 3 CYD staff members in attendance.

• Community Youth Development partnered with Cherokee Nation Environmental programs for the Environmental Festival on Friday, April 12<sup>th</sup>, where the schools brought in youth and they made key chains. There were 85 youth, 21 parents/teachers and 4 CYD staff who came to our station.

Mailed & handed out 210 copies of flyers about May youth activities to residents, community organizations & participants in Cherokee Heights, Greasy, Lost City & Tailholt; also e-mailed flyers about May youth activities to the B&G clubs in Keys, Marryetta and Cave Springs for them to post.

# **COTTA Technical Assistance Program**

COTTA hosted its Annual Community Leaders Conference on April 12-13, 2013. The Conference is planned, staffed and funded by the COTTA program. The objective of the conference is to introduce or orther the knowledge of the leaders of Cherokee communities in various aspects of community organizational functions. There were 375 Cherokee citizens in attendance at the conference, representing 73 community organizations. Of the 73 organizations represented, 49 were from within the 14 county jurisdiction, 22 were At-Large organizations and the CNCA Board. The training consisted of 33 different workshops focused on organizational functions and tribal culture. Booths were provided for 13 Cherokee Nation Programs, 1 Native Non-Profit and 1 Federal Agency to disseminate information regarding their programs. Surveys indicate that participants not only received valuable information at the conference but learned from sharing of experiences through networking with other organizations in attendance.

#### Volunteer Program

Volunteer staff worked with two volunteer groups Avon Lake UCC and Mission Methodist scheduled to be in the jurisdiction during the months of June and July. These two groups consist of approximately 490 individuals with varying ranges of skills and expertise. Arrangements have been made for housing and travel for volunteers in locations near the identified projects. Projects identified target the elderly, disabled and handicapped with a need. To date, 15 projects have been identified within a 30 mile radius of Brushy School for the June volunteers.

Volunteer Program staff provided tools and equipment and worked with volunteers to clean-up the Barber Cemetery.

## **Community Work/Building Program**

The 2013 Community Work grant awards were made to organizations in February. The following is a status on those projects:

- (1) Vian Peace Center, Food Pantry Electrical & plumbing complete; sheetrock in progress
- (2) Cherokee Elders, Community Building Has begun dirt work and excavation
- (3) Watts, Community Building Completing flooring & base trim
- (4) Orchard Road Community Organization, Outreach Center Parking lot Sidewalks & parking lot completed with savings, working on budget modification to remodel kitchen.
- (5) Fairfield, Pavilion Construction is in progress target completion date May 31.
- (6) Marble City, Walk-in freezer & Dock Budget modification approved last week
- (7) Oaks Sr. Citizen, Parking lot lights Awaiting permit from Oaks City Council. Council meeting scheduled for week of May 13.
- (8) South Coffeyville, Classroom/Office At a standstill until Water and Sanitation complete their portion of running the waterline.

Staff made contact with 29 community organizations regarding insurance on their buildings. As a result, 17 organizations have provided the required information to Risk Management and effective April 1 have insurance on their buildings. Two of the organizations contacted are self insured. Staff continues to make contact with community leaders and assist Risk Management with obtaining the required information for the remaining 10 organizations.

Staff processed 20 Cemetery Restoration Assistance applications during the month of April.

#### b. Notable events

1. The Oklahoma Attorney General's Office has begun disbursing financial settlements from the Oklahoma Mortgage Relief Settlement reached with the five big banks. The AG's Office received approximately 700 applications from Oklahomans who believed they were harmed by their lender; as of April 19th, 335 of those applications had been approved and financial settlements were being made. Financial settlements range from \$5,000 to \$20,000 with an average settlement of \$11,173. The remaining applications are still under review and updates will be provided as additional information is released.

- 2. Program to date, **424 families unable to obtain a non-predatory mortgage on their own** have completed self-sufficiency counseling and obtained a non-predatory mortgage.
- 3. YTD, Self Sufficiency staff members have worked with 25 families facing foreclosure. **Staff helped 4 families save their home from foreclosure**. 11 families are still in the process of trying to save their homes; 0 families have been referred to outside sources for assistance; 10 families have dropped out of the program.

The workshop is targeted at families in the midst of foreclosure; Self Sufficiency Counselors and HUD representatives will be available to help homeowners communicate with the loan servicers and attempt to find some resolution to their housing situation.
