The Cherokee Nation Warehouse desires to donate these items in "as-is" condition.

1-Deep Freeze

WHEREAS the Grace Point Outreach Center, located within the Cherokee Nation's jurisdictional boundaries, operates on limited funds, and donating said items would benefit them greatly.

BE IT RESOLVED BY THE CHEROKEE NATION that the Tribal Council authorizes Cherokee Nation Warehouse to donate these surplus items to Grace Point Outreach Center as set out above.
