A RESOLUTION CONFIRMING THE NOMINATION OF STEVE WILSON AS A COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;


WHEREAS, the Cherokee Nation Tax Commission Board of Commissioners was created and authorized by Title 68 §11 of the Cherokee Nation Code Annotated;

WHEREAS, a vacancy exists on the Board of Commissioners and Steve Wilson is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Steve Wilson is hereby confirmed as a Commissioner of the Cherokee Nation Tax Commission for the term from August 2012 expiring February 2013 as authorized by Legislative Act 1-90, the Act of February 10, 1990.




