STATE OF THE NATION Bill John Baker Principal Chief

Chief Baker commented on the reception held last night at the Hard Rock Hotel and Casino to send off two WWII Veterans and four Korean War Veterans to Washington D. C. as a part of this year's Warrior Flight. This week the first organized Tulsa Metro At Large community meeting was held with over 400 in attendance. The new Fish and Wildlife Association was launched just before the holiday. He provided highlights from our recently held Cherokee National Holiday. We have purchased Sequoyah's home and over two-hundred acres in Sequoyah County from the Oklahoma Historical Society. Chief Baker touched on the recently held Cherokee Awards Banquet. The

Joe Thornton Archery Range has been dedicated and opened just behind the One Fire field. Chief Baker read an extremely long list of Cherokees who we have lost over the past month. He requested a moment of silence for those who have passed.

COMMITTEE REPORTS

Monthly Reports:

Housing Authority - Gary Cooper

Mr. Cooper reported the next board meeting is tomorrow evening at 5:30. He provided an update on the storm damage to their warehouse. He reported they will be doing some office relocations soon to make more convenient. They are currently working with fifty families for major rehab of their homes. He gave an update on the number of families the Housing Authority assists each month. The Housing Authority currently has 248 employees with a Cherokee percentage of 95.2% and a Native American employment percentage of 98.4%. Next week the 9th and final Indian Housing Block Grant Formula Negotiated Rule Making Committee meeting will be held in Oklahoma City. Upon the completion of the meetings in Oklahoma City the HUD Deputy Assistant Secretary of Native American Programs will make her first official trip to the Cherokee Nation.

Cherokee Nation Business, LLC - Shawn Slaton

Mr. Chuck Garrett reported in the absence of Mr. Slaton. He provided highlights of the July CNB financials. He also provided an employee update by stated they have a total of 80.1% Native American employment. The quarter horse racing will commence every Friday, Saturday and Sunday at Will Rogers Downs through November 12th. Cherokee Cultural Tourism is offering a moccasin making class on October 1st. The Hard Rock Hotel and Casino Tulsa was recently recognized for its outstanding work in the community by the Metro Tulsa Hotel and Lodging Association. The 11th Annual Cherokee Art Museum and Market returns to the Hard Rock on October 8th and 9th. Speaker Byrd inquired about the percentage of completion on the Grove casino. Councilor Lay inquired about the Shawnee opening a casino in Guymon.
