BE IT RESOLVED BY THE CHEROKEE NATION, that Deacon Turner is hereby confirmed as a Board Member of Cherokee Nation Foundation for the term August 2011 expiring August 2015, as authorized by the Bylaws of Cherokee Nation Foundation.
