8. Question 10 of the IRR regulations:

Summary report:

- 1. FHWA and DOI reported the Oklahoma meeting had the largest amount of attendees nationally.
- 2. The formula change will be issued through an Indian Affairs Manual Directive (estimated within the first quarter of 2011). Appropriations (or CR's) will be distributed according to the agency's interpretation.
 - a. BIA and Tribal roads will continue at 100% CTC and VMT.
 - b. IRR road system will mirror the Federal-aid system functional classifications, determining eligibility.
 - c. No letters of inability to provide funding will be allowed from State DOTs.
 - d. There will be a grandfather clause for inventory prior to 2005 to continue to generate 100% regardless of ownership and class.
- 3. FY 2011 will be a transition year in which all Class 3,4 and 5 roads will continue to contribute CTC and VMT at 100%. FY2012 will implement the final interpretation.
