RESOLUTION NO. 03-25

COUNCIL OF THE CHEROKEE NATION

**A RESOLUTION CONFIRMING THE REAPPOINTMENT OF FAN ROBINSON AS A
COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

WHEREAS, the Cherokee Nation has exclusive tribal jurisdiction over the Cherokee Nation Reservation, the geographic scope of which is defined in federal and Cherokee Nation law; and,

WHEREAS, the Cherokee Nation Tax Commission Board of Commissioners was established and authorized under Title 68 §11 of the Cherokee Nation Code Annotated; and,


WHEREAS, the Principal Chief is authorized by Title 68 §12 to select the members of the commission subject to majority vote of the Council of the Cherokee Nation; and,

WHEREAS, Fan Robinson is duly qualified to be reappointed as Commissioner pursuant to the laws of the Cherokee Nation and is hereby nominated for reappointment.


BE IT RESOLVED BY THE CHEROKEE NATION, that Fan Robinson is hereby confirmed reappointed as a Commissioner of the Cherokee Nation Tax Commission, for a term of three (3) years beginning February 15, 2025 and expiring February 2028.






