### COUNCIL OF THE CHEROKEE NATION

### A RESOLUTION CONFIRMING THE REAPPOINTMENT OF FAN ROBINSON AS A COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and,

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation has exclusive tribal jurisdiction over the Cherokee Nation Reservation, the geographic scope of which is defined in federal and Cherokee Nation law; and,

WHEREAS, the Cherokee Nation Tax Commission Board of Commissioners was established and authorized under Title 68 §11 of the Cherokee Nation Code Annotated; and,

WHEREAS, the Principal Chief is authorized by Title 68 §12 to select the members of the commission subject to majority vote of the Council of the Cherokee Nation; and,

**WHEREAS,** Fan Robinson is duly qualified to be reappointed as Commissioner pursuant to the laws of the Cherokee Nation and is hereby nominated for reappointment.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Fan Robinson is hereby confirmed reappointed as a Commissioner of the Cherokee Nation Tax Commission, for a term of three (3) years beginning February 15, 2025 and expiring February 2028.
