**A RESOLUTION CONFIRMING THE RENOMINATION OF SHARON SWEPSTON
AS A BOARD MEMBER OF THE CHEROKEE NATION COMPREHENSIVE CARE
AGENCY BOARD OF DIRECTORS**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Comprehensive Care Agency was created and authorized as a Tribal Agency by Article V, Section 7 of the Constitution of the Cherokee Nation and Legislative Act #3-04;


WHEREAS, the Principal Chief is authorized by Section 5.E. of LA#3-04 to select the members of the Board subject to confirmation by majority vote of the Council of the Cherokee Nation,

WHEREAS, the term of office of Sharon Swepston expired April 2008 and she has been selected to be renominated by the Principal Chief.

BE IT RESOLVED BY THE CHEROKEE NATION, that Sharon Swepston is hereby confirmed as a Governing Board Member of the Cherokee Nation Comprehensive Care Agency for a term of (2) years from April 2008 until April 2010.


CERTIFICATION



The Cherokee Nation Comprehensive Care Agency was created and authorized as a Tribal Agency by Article V, Section 7 of the Constitution of the Cherokee Nation and Legislative Act #3-04.

The Principal Chief is authorized by Section 5.E. of LA#3-04 to select the members of the Board subject to confirmation by majority vote of the Council of the Cherokee Nation; and

The term of office of Sharon Swebston expired April 2008 and has been selected to be renominated by the Principal Chief; and

Sharon Swebston is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation for a term of (2) years from April 2008 until April 2010.
