A RESOLUTION AUTHORIZING CHEROKEE NATION ENVIRONMENTAL PROGRAMS TO DONATE ONE (1) NITROLUX AMMONIA ANALYZER TO THE NATIONAL ATMOSPHERIC DEPOSITION PROGRAM (NADP) IN CHAMPAIGN, IL.

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Cherokee Nation Environmental Programs has a Nitrolux continuous ammonia analyzer which has been replaced by an updated unit and is no longer needed;

WHEREAS, Cherokee Nation Environmental Programs has limited space to store unused equipment;

WHEREAS, Cherokee Nation Environmental Programs has an ongoing partnership with the National Atmospheric Deposition Program (NADP) through participation in the Mercury Deposition Network (MDN);

WHEREAS, the NADP staff has experience operating Nitrolux ammonia analysers and can make use of the equipment.

BE IT RESOLVED BY THE CHEROKEE NATION, that the Tribal Council authorizes Cherokee Nation Environmental Programs to donate one Nitrolux analyzer (serial number 30006) to the National Atmospheric Deposition Program (NADP).
