# APPROVAL OF MINUTES

Councilor Baker moved to approve the June 17th regular session minutes. Councilor Keener seconded the motion. The motion carried.

# REPORTS:

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn announced the Principal Chief's proposed budget is complete and is currently being prepared for delivery to the Council. She provided an update on the Grant Services Department. She announced the single audit over our federal funds is complete and they have received yet another clean audit. She introduced Joel Haaser, our Audit Director from BKD. Mr. Haaser gave an overview of the audits provided. Councilor Cowan Watts inquired about the reports being marked confidential.

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton reported they have had a strong June financially. He provided an update on all of the clinics and other projects. He announced they have started the paperwork for the South Coffeyville casino. They are also working hard on a mitigation plan for the upcoming expansion of the Creek's facility, Margaritaville. Councilor Cowan Watts requested copies of the justification for the sole source for HWH. Councilor Byrd inquired about Will Rogers Downs financially.

Career Services/Employment - Diane Kelley

Ms. Kelley showed the shirts that will be given to new employees at CNB who are hired through the program Cherokee Career Connections. She provided updates on the various ongoing projects. She gave clarification on the difference between the Day Work and On the Job Training Programs. Councilor Glory Jordan requested clarification on funding received and announced in the newspaper. Councilor Keener requested an update on the GED.

Commerce - Anna Knight

Ms. Knight offered to answer questions from the report provided. She announced the Northeast Oklahoma Regional Alliance Conference will be held at NSU on October 7th.
