**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Environmental Protection Commission was created and authorized by Title 27 Section 101 of the Cherokee Nation Code Annotated (CNCA);


**WHEREAS**, the Principal Chief is authorized to appoint members of the Commission subject to majority vote of the Council of the Cherokee Nation; and

**WHEREAS**, Marty D. Matlock is duly qualified to be reappointed as a Commissioner, pursuant to the laws of the Cherokee Nation;






