A RESOLUTION CONFIRMING THE NOMINATION OF TRALYNNA L. SCOTT AS TREASURER OF THE CHEROKEE NATION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, pursuant to Article VII, Section 12, of the Constitution of the Cherokee Nation, the Principal Chief is authorized to appoint the Treasurer subject to majority vote of the Council of the Cherokee Nation;


WHEREAS, the Office of Treasurer is defined in Chapter 4, Title 51 of the Cherokee Nation Code Annotated;

WHEREAS, Tralynna L. Scott is duly qualified to fill the office of Treasurer of the Cherokee Nation.


BE IT RESOLVED BY THE CHEROKEE NATION, that Tralynna L. Scott is hereby confirmed as the Treasurer of the Cherokee Nation, to fulfill the duties of Treasurer as specified by Article X of the Constitution of the Cherokee Nation for a term beginning August 2019 and ending August 2023.

The foregoing resolution was adopted by the Council of the Cherokee Nation at a duly called meeting on the 29th day of August, 2019, having 17 members present, constituting a quorum, by the vote of 17 yea; 0 nay; 0 abstaining.


