



AMBULATORY PATIENTS VISITS BY CLINIC, SEPTEMBER 2013




TOTAL AMBULATORY PATIENTS VISITS BY CLINIC, SEPTEMBER 2013



TOP FIVE AMBULATORY CARE DIAGNOSIS FOR CNHSG, SEPT 2013




Third Party Revenue By Clinic, SEPTEMBER 2013 (YEAR TO-DATE)



The Cherokee Nation

Nominated by the Oklahoma Chapter of the American College of Physicians for the coveted Edward R. Loveland Memorial Award for a distinguished contribution in the health field. The Cherokee Nation has been a health champion for years in Oklahoma. The statistics speak for themselves. Cherokee Nation is a leader and worthy to have its name alongside previous Loveland Award winners.

Cherokee Nation's vision is to achieve optimal health and healthy communities for this and future generations. Since 2002, the Cherokee Nation Health Services have performed over four million patient visits with eight health centers and one hospital. Working on one of the sickest populations in the country, programs include emergency medical services, diabetes, community health, cancer, behavior health, elder care, and youth/substance abuse services. The Cherokee Nation operates the largest tribal operated health care system in the United States.

The Cherokee Nation has received countless awards including eighteen awards from the Indian Health Services through the Government Performance and Results Act. The tribe is the first tribe to achieve accreditation by Det Norske Veritas. The Cherokee Nation EMS is the first tribe and first EMS service in Oklahoma to achieve the Commission on Accreditation of Ambulance Services (CAAS), meeting the highest national standards for the medical transport industry.

The W.W. Hastings Hospital, a sixty-bed hospital, located on the reservation averages 4,600 admissions, 13,000 inpatient days, 1,000 newborn admissions, and 3SQ,000 visits annually. The scope of services include acute/chronic care, inpatient hospital, pediatric care, podiatry, nursing, radiology, laboratory, physical therapy, pharmacy, dental, nutrition, optometry, contract health, diabetes prevention, cancer prevention, WIC (women, infants, and children), behavioral health, public health nursing, residential adolescent treatment center, and a healthy nation program (physical activity, healthy eating, and tobacco free). The hospital boasts professional affiliations with Northeastern State University for nursing and optometry, Southwestern State University for pharmacy, Bacone College for nursing and radiology, as well as partnerships with the University of Oklahoma and Oklahoma State University.

Of the eight health centers, the Three Rivers Health Center is the flagship. In a joint venture with the Indian Health Services (IHS), it is the largest health center with more than 100,000 square feet. In 2009, there were 70,764 outpatient visits. The scope of practice for the Three Rivers Health Center matches that of W. W. Hastings minus the inpatient services. It has services of mammography, rheumatology, and Cherokee language translation services, not offered at Hastings. The other seven health clinics are located in Bartlesville, Jay, Nowata, Salina, Sallisaw, Stilwell, and Vinita. These clinics have totaled 328,159 outpatient isits a year. This regional coverage allows healthcare access of close proximity.

Cherokee Nation is the only tribe in the United States with a cancer registry. The registry is a National Cancer institute's (NCI) collaboration geared toward Surveillance, Epidemiology and End

Results (SEER). The registry collects information on the type of cancer, the stage of disease, and how and when the cancer is diagnosed and treated.

The Behavioral Health Services of Cherokee Nation offer programs including mental health services, subtance abuse treatment, and community-based mental programs. A chemically-dependent Indian adolescents program for ages 13-18 years of age deals with serious substance abuse in a residential setting. The program serves Native American youth with substance abuse by promoting educational, mental, spiritual, emotional, and physical growth.

Most importantly, the Cherokee Nation Healthy Nation provides outreach services to schools and communities in wellness, health fairs, tobacco cessation, running clubs, recreation centers, fitness camps, and culturally appropriate education. Through these services and efforts, the population is striving to be healthier.

The Oklahoma Chapter of the American College of Physicians is proud of Cherokee Nation and its healthcare efforts, a model for others. The Loveland Award represents a distinguished contribution in the health field, Cherokee Nation truly fulfills this criteria. Cherokee Nation continues to provide high quality, low cost, high value health care to many of Oklahoma citizens.

Subject: September 2013 Executive Summary for W.W. Hastings Hospital

- In an effort to achieve better service and a more financially beneficial arrangement for Cherokee Nation, the CEO participated in the workgroup that is reviewing the current contract between Cherokee Nation Health Services and Northeastern State University's Oklahoma College of Optometry (NSU OCO).
- As part of our ongoing expansion of the health campus in Tahlequah, CEO participated in the bid interviews with architecture and engineering firms that submitted bids for the design of a new hospital. The bid interview process ultimately resulted in the selection of the Red Fern Group, a partnering of Selser-Schaefer, Childers, and Perkins and Will.
- To further engage our patients, we conducted our monthly patient breakfast at WWH in the Administrative Conference Room.
- To ensure the sustainable service lines for our patients, we met with Darrell Collins from Great Plains Sleep Specialists to discuss revisions to our contract with them to continue providing polysomnography testing for patients while minimizing costs to Cherokee Nation Health Services.
- To provide reward and recognition to our staff, we provided meals to both the day and night shifts of our Medical-Surgical staff and providers.
- Due to ongoing disciplinary needs for IPA employees, a conference call was conducted with staff from the Oklahoma City Area Office for IHS; the call included department directors and executive leadership from Cherokee Nation Health Services and was conducted on Wednesday, September 18th.
- In recognition of Dr. Franklin's service in Afghanistan with the United States Air Force, a US flag flown by Dr. Franklin during a mission was presented and put on display in our Emergency Department on September 24th.

CN W.W. Hastings Hospital-September report

Announcements

- Beginning in September, W.W. Hastings began to offer free influenza and pneumococcal vaccines to patients and staff. Receiving the influenza vaccination is mandatory for employees of W.W. Hastings Hospital and those that decline are required to participate in an educational session.
- Improvements in Physical Therapy's operation have yielded significant improvements in access as evidenced by
 our ability to treat patients at WWH and avoid utilizing Contract Health Services for PT referrals. In addition to
 improving access, PT is realizing improvements in documentation and productivity. Our Hospitalists have been
 provided with a portable ultrasound system to enable them to perform diagnostic imaging at the bedside as well as

assist with invasive procedures such as insertion of central venous access (e.g., peripheral inserted central catheters [PICCs]).

Achievements

- The American Society of Health System Pharmacists granted accreditation for the next six years to the pharmacy residency at W.W. Hastings Hospital.
- Dr. Martin Jacob was recently awarded certification from the American Board of Obstetrics and Gynecology Subspecialty Board Certification in Female Pelvic Medicine and Reconstructive Surgery (FPMRS -aka "UroGynecology") as part of the first inaugural group in the country to be awarded this distinction by the American Board of Obstetrics and Gynecology

Volume

- The Emergency Department (ED) and Urgent Care treated 5,484 patients during September and experienced a Left Without Being Seen (LWOBS) rate of 9%. The ED again saw an increase in the percentage of patients admitted with 8.43% of our ED patients being admitted at Hastings; our admission goal is 12%.
- Our Transport Service transported 137 patients and logged 7,299 miles during September.
- Surgical Services performed 378 procedures during September 2013 and, again, achieved 100% compliance with its Surgical Care Improvement Project (SCIP) measures. Surgical Services staff again met and exceeded its goals for turnover time for OR suites for both major and minor cases.



- Breast and Cervical cancer early detection Program The program served 311 women served (Clinical Breast Exam, Mammograms, Ultrasound, Pap smear, HPV testing, Colposcopy with or without biopsy) during the month of September at the cost of \$35,777.

- Comprehensive Cancer Program (CCC program) The Outreach Coordinator, Greg Bilby presented: Prostate Cancer Education presentation, Stigler 27 participants Wilburton,9 participants, Catoosa Hard Rock Conference Center,200 participants, Tobacco Tour- Brookland Elementary, AR,1200 participants Nemo Vista School, AR,145 participants Bay Elementary, AR 250 participants. CDC Site Visit: Two CDC Project Officer's visited the Tobacco Free Hard Rock.

- Cancer Registry—The Cherokee Cancer Registry now has a total of 6235 cases in the SEER*DMS system. The completeness for 2011 cases is 99.37% for November2013 Submission, this has improvement of 45% compared to last year's submission rates. The top Cancer sites are, Lung and Bronchus, Breast, Prostate, Kidney and Renal Pelvis. The registry staff is working on developing a data sharing agreement with the CN-Breast and Cervical Cancer program. We have an ongoing collaboration with the Oklahoma State Central Cancer Registry. Cherokee Nation data will be updated with the Vital Status data starting next week which will help with our numbers for submission.
- CN Emergency Medical Service—handled 305 calls, of those 152 required emergency transport, 130 were transferred. In addition program provided EMS training to 657 participants of those 325 were Native Americans.
- **Behavioral Health Services** Behavioral Health provided mental health and substance abuse services to **1286**patients, of those **907** were **unduplicated patients** were served at the Tahlequah and CIH sites, of the patients served **778** were Cherokees.
- Jack Brown Center—The JBC currently has 18 residential clients, 11 males and 07 females. Twelve clients are on waiting list. Staff offered educational sessions though out tribal jurisdiction.
- Pharmacy Services—the program filled 154,678 prescriptions (an increase of 16.56 from last year) @ the cost of \$1,161,779. POS collections for month of August were up by 29% and paid 100.8% of the cost of medications. 90 day solutions—Council will review and pose questions in September, 90 day dispensing will be an option starting October 1st. Jay pharmacy—Robotics contract issues have been resolved and down payments are being processed for purchase and install. Late November/Early December are a possible start date for services. Ochelata weekly plan reviews continues, the planning is near 90% completed.
- Healthy Nation Program—Community Health Program Liaison Randy Gibson report: Program Liaison report: Healthy Nation was invited to be the feature interview during the University of Oklahoma—University of Texas pregame show prior to the game on Oct 12. Randy Gibson, Program Liaison, was interviewed about the Healthy Nation program and our efforts to combat obesity, heart disease, commercial tobacco use and the dangers of secondhand smoke. The interview was heard on 32 stations throughout Oklahoma and heard by an estimated 500,000 listeners.
- Community Health Program report from Northern Counties: The Healthy Nation Public Health Educators are focused on implementing the Principal Chief's School Health Leadership grants since school has started around Cherokee Nation. The school recipients are doing Body Mass Index measurements on all their students as stipulated in the grant guidelines. The schools Physical Education Teachers with assistance from the Public Health Educators are doing a pre-test BMI on all students that is to be completed on or before October 10, 2013. The schools will do a follow up posttest measurement during the month of May, 2014.
- This testing is a major incentive to the grant recipient schools to concentrate on Diabetes prevention and the improvement of overall student health in Cherokee Nation. The initiative has been well received by the schools and has already been successful in emphasizing the need to highlight improved dietary practices in the schools as well as the desire to improve physical education requirements. One of the grants major goals is to improve school nutrition and another is to enable schools to fund quality physical education efforts. The BMI testing will provide Healthy Nation hard data to use in their continuing efforts to combat the increase of Diabetes among our tribal members and within our tribal jurisdiction. The Public Health Educators are working very hard to implement the goals of the grant in order that the tribe's health will be improved now and for future generations.
- During the month of September the Public Health Educators have been working with the Community Transformation Grant (CTG) in several communities throughout the Cherokee Nation. On September 30, 2013, several Healthy Nation Public Health Educators took part in a walkability study in Nowata that was part of the CTG. This walking audit was led by Dan Burden, a nationally known expert on community improvement. The study is focused on improving safe walking and biking routes to schools. The walking tour pointed out many improvements that could be made in Nowata to encourage students to walk to school and or ride their bikes to school. This would greatly enhance the student's opportunities to get more exercise and also help the schools with traffic problems in and around the school zones. The following evening, October 1st, Mr. Burden addressed community leaders from Pryor and Nowata and detailed ways that both communities could improve their walkability in very cost effective ways in the short term and also how to develop long term plans for each towns continued encouragement of walking and biking by their citizens. He was very clear in stating that walking and biking would support the goals of increasing the level of good health among the citizens of Cherokee Nation. Mr. Burden has made himself available to assist the Public Health Educators going forward in their efforts to increase physical fitness.
- Community Health Program report from Southern Counties: <u>Sequoyah County</u>

- Bird Walk/Run 5k September 14- Tahlequah, OK with 378 participants, 10/10 garden beds have community sponsors. Total produce that was harvested includes: radish's, carrots, cherry tomatoes, banana peppers, Cheyenne peppers, large tomatoes
- Public Health Nursing—made 498 home visits to provide services dressing changes/wound care, monitoring vital signs, education, management of medication planners, blood draws, and B12 injections, assessment of home safety/environment, DM self-management and education. PHN staff also performed 82 post-partum follow ups, and provided transportation to 250 clients to our clinics, WIH, CIH and contract facilities.
- Public Health Nursing programs at Claremore Indian Hospital and Hasting Indian Hospital—A total of 4,459 contacts were made with patients including 157 Home visits.
- by the new test equipment and conducted staff-in-training on the new equipment and modified checklists. Began negotiations with Alko Enterprises to provided service support for digital imaging and mammography PAC systems at CN clinics. The staff installed A/C units at Vinita Health Center Lab, began installation of 3 A/C units in dental area at the Vinita Health Center. Gazebo at Three Rivers Health Center 25% completed .Retrieved/delivered surplus equipment from Health Admin, CN Natural Resources, Healthy Living Campus, Health contracts and Salina Health Center. Constructed shelving units at OES building/warehouse. Conducted spot inventory of Cherokee Nation equipment at NSU Optometry School. Purchased materials for remodel at the Employee Clinic. The staff performed risk assessments at Three Rivers and Vinita Health Centers. Conducted walk through inspection at Salina Health Center. Provided job training for the Safety Officer at Salina Health Center. Ordered thermometers to replace VFC 70 Refrigeration Monitors which are no longer legal for use in vaccine storage situations. Director participated in planning meeting for CT install at Three Rivers Health Center CN Health Services currently has 144 GSA/Tribal vehicles in inventory, unchanged from previous month.
- Cherokee Elder Care (CEC) Report—September enrollment was 122 participants. Current staffing includes 52 FTEs and 4 PTEs. We have increased staffing of 8 FTE's since January 2013 with 4 internal transfers to Cherokee Nation, one termination and 2 voluntary resignations year to date. LeShay Rhodes, joined CEC team as the Human Resource Manager. Due to growth the following are available positions: Masters Level Social Worker, Nurse Case Manager, Physical Therapist Assistant and Home Health Coordinator. Renovation of facilities is 70% complete. This will allow an additional 3600 square feet for participants and additional staff within the Adult Day Health Center and clinic. The Intake and Marketing team are working on new strategies for the 2014 year. Intake and Marketing focused heavily in the Muskogee area during September with 6 presentation/events.
- Staffing Report—Total number of filled position were 2,031. Four provider positions were filled during the month.



- Contract Health Services—the CHS program processed 5,975 referrals, of those 5,810 (97.2%) were approved at the cost of \$3,266,044.
- CHS Special funding initiative update— The program was established as a result of passage of "Cherokee Nation Corporation Health Dividend Act of 2011 (Cherokee Code Annotated: Title 18, Article 3 § 18) which was amended in November 2011 to increase the amount of the monthly dividend from CNB profits from 30%

- annually to 35%. The additional 5% of the corporate dividend will be used exclusively to provide services to Cherokee Nation citizens living within the jurisdictional boundaries of the Cherokee Nation. The services covered include, but are not limited to, eyeglasses, dentures, prosthesis, cancer treatments and hearing aids. At present, the process of handling these claims are as follows:
- Most of these referrals are termed "Call In's". These are emergent referrals where patient access health care services via an ambulance or an emergency room, bypassing the typical Indian Health Services route. Once we receive the request one of three outcomes are possible the referral can be approved, deferred pending further medical information or denied.
- Referrals are deferred pending further medical information for a few reasons. For example, the medical information on these referrals is minimal due to the emergent nature of the situation.


