WHEREAS, the U.S. Environmental Protection Agency has funds available to train tribal members in Brownfields Cleanup Projects;

WHEREAS, this grant will provide environmental remediation training to tribal citizens and better their chances for obtaining and sustaining employment.

BE IT RESOLVED BY THE CHEROKEE NATION, Cherokee Nation Office of Environmental Programs is authorized to submit a formal application should the proposal be selected for said project and that Chad Smith, Principal Chief (or his designee) shall be authorized to conduct contract negotiations and execute all official documents in this regard.

## **Brownfields Job Training Grant**

## Program Description

The Cherokee Nation Environmental Programs (CNEP) and Cherokee Nation Career Services plans to develop environmental cleanup courses to enhance the job placement of its Tribal members. The proposed program plans to provide training to 70 students over a two year period. These trainings will be offered twice during the 2 year project period and will include 136 hrs of combined classroom and practical application each year.

The classes offered will include 40 Hour Hazwoper Training (required) and Specialized Environmental Cleanup Operations (SECO). SECO is a three week training program that addresses various cleanup operations such as Lead Based Paint Work Practices, Asbestos Remediation Technician, Mold Remediation, All Appropriate Inquiry, and Hazardous Materials Sampling. Other trainings may be added such as methamphetamine clandestine drug cleanup if the time and resources are available. These training sessions will be offered between each semester to avoid any scheduling conflicts with Northeastern State University's activities during the normal academic classes. At the completion of all of the SECO classes an examination will be given to the students that complete five of the classes. Students who successfully complete this exam will receive their SECO certification.
