**A RESOLUTION CONFIRMING THE NOMINATION OF LINDSEY EARLS AS AN EDITORIAL BOARD MEMBER OF THE CHEROKEE PHOENIX**

**WHEREAS**, the Cherokee Nation, since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee People; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and

**WHEREAS**, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 19-00;


**WHEREAS**, Lindsey Earls is nominated by the Council of the Cherokee Nation to serve a term as Editorial Board Member of the Cherokee Phoenix, as authorized by Legislative Act 16-09;

**WHEREAS**, Lindsey Earls is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.


**BE IT RESOLVED BY THE COUNCIL OF THE CHEROKEE NATION** that Lindsey is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a term effective July 11, 2022 through July 31, 2028, as authorized by Legislative Act 16-09, the Act of June 15, 2009.




