### CALL TO ORDER

Chair Jack Baker called the meeting to order at 3:10 p.m.

### INVOCATION

Councilor Garvin gave the invocation.

### APPROVAL OF MINUTES

Councilor Bill John Baker made a motion to approve the September 25th regular session, September 15th sub committee, and the September budget hearings. Councilor Thornton seconded the motion. Motion carried.

### REPORTS:

Financial Report/Treasurer Report - Callie Catcher

*Ms. Catcher offered to answer questions pertaining to her written report. She requested the agenda be amended to discuss an opportunity regarding the 2006 health care bonds.*

*Ms. Catcher provided a handout of information pertaining to the buyback opportunity.*

Councilor Bill John Baker made a motion to amend the agenda to include discussion pertaining to the buy back program. Councilor Glory-Jordan seconded the motion. Motion carried.

AN ACT AUTHORIZING THE CANCELLATION AND REPLACEMENT OF CHEROKEE NATION INDEBTEDNESS ISSUED PURSUANT TO THE SERIES 2006 HEALTH CARE SYSTEM BONDS; AND DECLARING AN EMERGENCY

*Ms. Catcher announced the insurer of the bonds had a credit reduction and has fallen outside of the investor who purchased the bonds policy therefore the bonds need to be sold. The bonds are being offered at a discount that would give us an immediate savings of \$189,000. She stated we have a long term education reserve from motor fuels tax funds which contains approximately \$20ml and earns approximately 2% and is dropping with our interest rates. These funds are restricted through 2017 and we can not expend the funds but are allowed to invest them to earn interest.*

*Ms. Catcher stated she and Mr. Evans would need to draft a resolution to be approved at the Council meeting that authorizes the cancellation of \$.3365ml of the 2006 series health care bonds and replaced by a note payable to the motor fuels tax reserve account with the debt service the same. Mr. Evans pointed out bond value typically goes in the opposite direction of interest rate movements. He stated this is a huge opportunity for a savings to the Nation.*

**Councilor Bill John Baker moved for the approval. Councilor Cobb seconded the motion. Motion carried.**

Cherokee Nation Enterprises - David Stewart

*Mr. Stewart announced they ended the year at approximately \$118ml which is 6 to 7% above last year. West Siloam will open November 10th and the casino portion at Catoosa on the 15th of December. He stated they plan to be very conservative over the next six months with hiring and expenses due to the economy.*

*Mr. Guy Wolcott announced September wrapped up fiscal year 2008 with a 7% increase in net income and a 5.5% increase in revenue over 2007. The month of September ended softer than anticipated. He stated they anticipate drawing upon the credit line by the end of this fiscal year.*

Cherokee Nation Industries - Robert Drvostep

*Mr. Drvostep offered to answer question from the written report provided. Councilor Glory-Jordan inquired if they expect a turn around in the upcoming year. Mr. Drvostep stated this year they are budgeting a profit of \$.84ml.*

Cherokee Nation Businesses - David Stewart

*Mr. Bob Huffman reported CNB was recently granted \$60ml in new market tax credits from the U.S. Treasury. He stated this award is the only one to go a tribe or tribal entity. He stated these funds would be used to provide low cost financing for businesses in Oklahoma.*

Career Services/Employment - Diane Kelley

*Mr. Jon Overacker offered to answer questions from the report submitted by Ms. Diane Kelley. Mr. Overacker inquired if the new TERO report format was easier to follow. The committee agreed to the new format.*

Commerce - Anna Knight

*Ms. Shay Smith offered to answer questions of the Commerce Department written report. Councilor Glory-Jordan requested continuing reports pertaining to bad debt write off.*

Historical Society - Carey Tilley

*Mr. Tilley gave a brief overview of his written report. He encouraged everyone to come out to see the beadwork exhibit. A special reception will be held to honor the guest curator Martha Berry this Saturday from 2 -4:00 p.m.*

CONSENT ITEMS:

T.E.R.O. CERTIFICATIONS

*Councilor Bill John Baker moved to accept the certifications as presented. Councilor Garvin seconded the motion. Motion carried.*

#### CEMETERY RESTORATION ASSISTANCE APPLICATIONS

*Mr. Evans announced there is one addition to the cemetery applications for 7 in total. The additional is in District 1 for Agent Cemetery. Councilor Coates made a motion for approval. Councilor Fishinghawk seconded the motion. Motion carried.*

#### LAW ENFORCEMENT REQUESTS

*Mr. Evans stated there are no law enforcement requests this month.*

#### COMMUNITY ASSISTANCE

*Councilor Bill John Baker announced he has received a request from the Cherokee Basket Weavers Association who claim to have members in all 14 counties as well as At Large. They are taking an exhibition to Washington D.C. to the Smithsonian to represent Cherokee baskets. The request is in the amount of \$4,000. Councilor Bill John Baker inquired as to how many Councilors would offer \$250 of their community assistance funds. Councilor Cowan Watts asked if they have applied for a community works grant. Councilor Bill John Baker stated he is unsure. Councilor Cowan Watts stated although not all allocated at this time all of her funds are spoken for in her community. All Councilors with the exception of Cowan Watts gave \$250 of their community assistance funds.*

*Mr. Evans announced an error in the community assistance spreadsheet with Sperry Alumni Association as it shows \$10,000 and should be \$1,000. He stated there are 7 additions since the report was mailed out. These additions include:*

Muldrow Cherokee Community Organization - Fullbright \$1,000  
Redbird Smith Council Grounds - Fullbright \$1,000*

Cherokee Childrens Mission - Crittenden \$250, Fishinghawk \$250, B. Baker \$250  
and Glory-Jordan \$250*

*Councilor Thornton made a motion for approval with additions. Councilor Crittenden seconded the motion. Motion carried.*

#### ROADS

*Mr. Evans announced an amended roads packet had been provided. Councilor Buzzard made a motion to approve as amended. Councilor Fullbright seconded the motion. Motion carried.*

*Mr. Evans announced the motor vehicle funds would be coming forward in January when the apportionment is done by Callie's group for the car tag revenues.*

Councilor Cobb inquired who determines what is reasonable. Mr. Hembree suggested a 2 mile radius. Councilors Bill John Baker and Buzzard accepted the suggestion.*

He stated after reviewing the submission of Mod 1 he found no technical issues surrounding the requests nor did he have any concerns related to their respective carryover estimates. The only concern he voiced were the ones noted in his review which were*

*Mr. Evans clarified the \$10,000 for Ga Du Gi projects is to be included in the mod package.*
