CALL TO ORDER

Chair Buzzard called the meeting to order at 9:05 a.m.

INVOCATION

Councilor Snell gave the invocation.

APPROVAL OF MINUTES

Councilor Bill John Baker made a motion to approve the June 16, 2009 regular session minutes. Councilor Cowan Watts seconded the motion. Motion carried.

REPORTS:

1. Human Services Department - Norman Merriman

Mr. Snell commented the School Voucher Program issued 2,000 vouchers. He thanked the Council for issuing water for the participants that helped at the sites. Councilor Glory-Jordan requested a breakdown of how many participants for each county. Also, she requested next year look into the free lunch program for the kids that come to the school voucher program. Mr. Snell announced they have started the summer cooling program for the elderly and disabled. They have approximately 1,250 elderly and disabled participants and each one has received an estimate of \$300.00 per household that qualify.

2. Community Services - Charlie Soap

Mr. Soap offered to answer any questions from his written report. Councilor Baker inquired about the proposal from the Arts & Humanities Council. Mr. Soap stated they have received funding from their department. Councilor Snell inquired about the Oaks Water and Sewer plant. They are trying to get it cleaned up for a new lagoon. Councilor Buzzard stated the \$37,000 that came from the Stimulus Funding might

help with the work that needs to be done. Mr. Soap stated he would look into it and get back with the Council. Councilor Cowan Watts questioned if the funding is available for the bigger projects for the Cherokee Arts and Humanities. Mr. Soap stated they usually encourage them to go outside the Nation and try to get the money from other organizations and entities.

3. Roads & Transportation - Michael Lynn

Mr. Hood stated the Honey Hill Waterline project is complete but is still waiting on the cable and power companies. The Kansas Dry Creek Project Plan is scheduled for July 28, 2009 at 10:00 a.m. The Ottawa County Bridge Ribbon Cutting Ceremony will be July 22, 2009 at the bridge. Councilor Buzzard inquired if the Honey Hill Project is part of the stimulus money. Mr. Hood stated it is not.
