#### CALL TO ORDER

Chair Byrd called the meeting to order at 1:05 p.m.

Chairman Byrd gave the invocation.

# APPROVAL OF MINUTES

Councilor Hargis moved to approve as submitted. Councilor Vazquez seconded the motion. The motion carried.

# REPORTS:

Marshal Service - Shannon Buhl

Marshal Buhl announced one of the Marshals was awarded with a plaque from the Elks Lodge for helping a choking person while at lunch. They raised just over \$4,600 for the Polar Bear Plunge held last week.

Office of the Attorney General - Todd Hembree

Ms. Sara Hill reported in the absence of AG Hembree. She gave an update on the pending court cases. The mock trial was held last week for the high school students. The BIA guidelines for State courts, which are important in ICW cases, have been updated for the first time in thirty years.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin reported on the number of FOIA and GRA requests submitted for the past month. She continues to get the past year uploaded on the website. Councilor Lay inquired about her office location.

Election Commission - Bill W. Horton

Councilor Fishinghawk inquired who does the background checks and/or investigations on the candidates when they file for office.

Tax Commission - Sharon Swepston

Ms. Swepston offered to answer questions from the report provided.

Marshal Buhl provided clarification on the Marshal Services role in the election candidate's background checks or investigations.

Self-Governance - Vickie Hanvey

Mr. Clint Hastings reported in the absence of Ms. Hanvey. He gave a brief overview of the meetings Ms. Hanvey is currently attending in Washington D.C. He read a letter they received from another tribe in which they assisted in their self-governance IHS claims. He commented on the President's request to move the CSC funding from discretionary to mandatory. They have been working on the BIA roads inventory at Sequoyah High School. Councilor Keener inquired if the unpaid claims settlement could be itemized.

Gaming Commission - Jamie Hummingbird

Mr. Hummingbird reported the South Coffeyville casino was successfully opened in the middle of a snow storm. They are now geared toward and focusing on the Roland facility with a mid-May opening. He provided a handout showing the total amount of compact fee payments made by all tribes.

Human Resources - Nason Morton

Mr. Morton introduced their recruiter, Chase Murphy. Councilor Taylor inquired about Mr. Murphy's background.
