BE IT RESOLVED BY THE CHEROKEE NATION, that Fredia Vann is hereby confirmed as a Board Member of Cherokee Nation Community Association Corporation for the term (4) years from March 2008 until March 2012, as authorized by the Bylaws of Cherokee Nation Community Association Corporation.
