# Meeting Minutes Community Services Committee

#### CALL TO ORDER

Chair Buzzard called the meeting to order at 9:10 a.m.

INVOCATION

Councilor Snell gave the invocation.

#### **ROLL CALL**

#### APPROVAL OF MINUTES

Councilor Bill John Baker made a motion to approve the June 17th regular session minutes. Councilor Jack Baker seconded the motion. Motion carried.

#### REPORTS:

1. Human Services Department - Norman Merriman

Ms. Norma Merriman announced an increase in food distribution services. She suggested everyone keep in mind an alternate resource of Angel Food Ministeries. Councilor Glory-Jordan inquired how the program is funded. Ms. Merriman stated it is funded through USDA. Councilor Glory-Jordan inquired how they adjust to the increase. Mr. Jerry Snell stated the funds received for the program are strictly for administrative purposes. The food is provided by USDA. We order food every month. The average now is 9,200 individuals or 3,700 households monthly.

Councilor Fishinghawk inquired if there is a program to assist with air conditioners. Ms. Merriman stated there is a program but they are out of units at this time. She stated to qualify you must be LIHEAP eligible and must have a doctors statement of need. She stated they can provide fans if needed.

Councilor Bill John Baker made a motion to move \$2,500 to Executive and Finance Committee to supplement the air conditioning program. Councilor Fishinghawk seconded the motion. Councilor Soap inquired if the units would all be purchased at the same time or on an as needed basis. Mr. Snell stated they will purchase as many as they can at one time to get a better deal. He stated in the past they have purchased 10,000 btu units. Councilor Bill John Baker amended his motion to \$5,000 to purchase the 10,000 btu units. Motion carried.

Ms. Merriman announced they are in the second week of the school clothing voucher program. The vouchers this year are for Stage Department Store. She stated they partnered with the Registration Department this year to assist in verifying tribal citizenship. Councilor Cobb inquired as to Stage's reaction to the process. Ms. Merriman stated they have a meeting scheduled after the event is over. Ms. Merriman stated they will be in Jay today, Tahlequah tomorrow and Stilwell Thursday. Councilor Glory-Jordan requested the number of vouchers given at each site be emailed to Shelli for distribution to the Council.

Chair Buzzard requested an update of the burial program. Ms. Merriman stated they have received notice from almost all of the funeral homes stating they are loosing money and asking for \$3,000 for a funeral service. Mr. Jerry Snell stated they are in the process of revising the burial policies now but he is unsure if they will be able to increase the amount. He stated the existing contract with the funeral home is \$2,400 with \$100 for a wake. He stated the new proposed modification will incorporate some tribal funds. He stated before it was just a resources guideline with tribal funds used there will be income guidelines as well.

#### 2. Community Services - Charlie Soap

Mr. Charlie Soap stated they have a lot of projects moving along. Councilor Cobb inquired about the bilingual signage. Mr. Soap stated the first bilingual sign will go up on Red Barn Road. Councilor Glory-Jordan inquired about the status of the self-help housing policy. Mr. Soap stated the Chief is reviewing them now then they will move forward to the Commerce Department.

#### 3. Housing Services - David Southerland

Mr. David Southerland stated the Chief has requested a special legislative conference to go over the revisions to the rehab policy. The stated the Housing Authority Board meets tonight. Councilor Glory-Jordan requested Mr. Southerland attend the housing work group meetings. Mr. Southerland stated any program receiving NAHASDA funding has been requested by the Administration to attend the meetings. Councilor Fishinghawk inquired about the status of the COBRA request. Mr. Southerland stated it is on the board agenda tonight.

#### **OLD BUSINESS**

#### 1. WATER NEEDS FOR RURAL WATER DISTRICTS (STATUS UPDATE)

Mr. Soap stated it was his understanding to obtain the engineering reports and determine the real need. Mr. Soap stated one of the major concerns is where are the major leaks. He stated on of the reports suggests some of the valves were improperly installed and they are reviewing this as well. Councilor Bill John Baker stated the Oklahoma Circuit Writer came by with an update stating it would cost more in time and repair than it would for replacement. Chair Buzzard proposed over the next month to review the reports and determine where to begin and the possibility of funds. He requested a breakdown of the funds spent on this rural water district over the last three years. Councilor Glory-Jordan inquired if assistance had been requested from Stillwater. Mr. Dick DeGeorge stated they have requested assistance from the USDA in Stillwater and they are willing but have requested some inkind assistance.
