**A RESOLUTION AUTHORIZING THE CHEROKEE NATION TO
DONATE A SURPLUS ITEM TO THE FAIRFIELD COMMUNITY
ORGANIZATION INC.**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

WHEREAS, the Cherokee Nation desires to donate the item in “as-in” condition

1 – lawn mower (Green Bobcat Zero Turn 183L71V0119); and,

WHEREAS, Fairfield Community Organization Inc., located within the Cherokee Nation Reservation, operates on limited funds, and donating said item would benefit them greatly; and,

BE IT RESOLVED BY THE CHEROKEE NATION, that the Council of the Cherokee Nation authorizes the Cherokee Nation to donate this surplus item to Fairfield Community Organization, Inc. as set out above.


