WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that has been deemed surplus: 7- Black Chairs, 13- Blue Chairs, 5- Desks, 1- Table, 2- Cabinet Shelves.




