#### COUNCIL OF THE CHEROKEE NATION

## A RESOLUTION CONFIRMING THE NOMINATION OF JIM WILCOXEN AS A JUSTICE OF THE CHEROKEE NATION SUPREME COURT

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Justices of the Supreme Court are authorized in Article VIII Section 1 of the Constitution of the Cherokee Nation;

WHEREAS, according to Article VIII Section 2 of the Constitution, the Justices shall be appointed by the Principal Chief and confirmed by the Council of the Cherokee Nation;

WHEREAS, the terms of office for the Justice of Seat one (1) of the Supreme Court expires December 31, 2010;

WHEREAS, the Principal Chief has appointed Jim Wilcoxen as a Justice of the Supreme Court of the Cherokee Nation, Seat 1, to fulfill the duties of Justice as articulated in Article VIII of the Constitution;

WHEREAS, Jim Wilcoxen is duly qualified to fill this position.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Jim Wilcoxen is hereby confirmed as a Justice of the Supreme Court of the Cherokee Nation, Seat 1, to fulfill the duties of Justice as specified in Article VIII of the Constitution of the Cherokee Nation for a term beginning January 1, 2011 and ending December 31, 2020.
