## COUNCIL OF THE CHEROKEE NATION

## A RESOLUTION CONFIRMING THE APPOINTMENT OF DANIEL MEAD AS MARSHAL OF THE CHEROKEE NATION

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

**WHEREAS**, pursuant to Article VII, Section 14 of the Constitution of the Cherokee Nation, the Principal Chief is authorized to appoint the Marshal subject to majority vote of the Council of the Cherokee Nation; and,

WHEREAS, Daniel Mead has demonstrated exceptional commitment and service during his term as Acting Marshal of the Cherokee Nation; and,

WHEREAS, Daniel Mead is duly qualified to fill the position of Marshal as specified in Article VII, Section 14 of the Constitution of the Cherokee Nation and is hereby nominated for appointment.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Daniel Mead is confirmed as the Marshal for the Cherokee Nation for a term of five (5) years beginning October 2025 and ending October 2030.
