Budget Highlights

- April 2013 CNB consolidated net income of \$7.5 million was 22.1% unfavorable to a budget of \$9.6 million.
- CNE net income of \$8.4 million was \$1.2 million lower than budget. Lower than budgeted revenue in addition to higher than
 budgeted expenses related to increased employee expense as well as costs related to the widening project of Highway 75 near
 Ramona drove the variance.
- The Technology Portfolio experienced net income of \$421,000, which was 10.2% above budget due to higher than budgeted awarded contracts.
- CNB Parent company net loss of \$952,000 was \$753,000 unfavorable to budget. The budget variance was driven by lower revenue
 related to a shared service true up, higher than budgeted employee expense, and a one-time YTD expense adjustment.
- Combined, all other entities were \$248,000 below budget.

Operating Highlights

- CNE net income of \$8.4 million in April was \$1.2 million unfavorable to budget.
- Total revenue of \$46.3 million was \$463,000 unfavorable to budget due to higher than budgeted promotional allowances.
- Total operating expense of \$33.9 million was 3.3% unfavorable to budget primarily due to higher gaming related expense as well as
 costs associated with the Highway 75 construction project near Ramona.
- The new hotel tower at Catoosa is now completely opened.
- Eastern Shawnee opened the Indigo Sky Casino near Seneca, MO November 8, 2012. The Indigo Sky Casino was built and replaced the Bordertown Casino.
- The Choctaw casino in Pocola is expanding its gaming floor from 1,400 to 2,500 games. This could negatively affect gaming activity
 at the Roland casino.
- The Creek Casino in Tulsa is planning a \$250 million expansion including a 500-room hotel tower, new casino and restaurant, pool bar, theater and event center, with an expected completion date of early 2015.

Operating Highlights

- The IT Portfolio generated revenue of \$8.7 million compared a budget of \$7.7 million.
- April EBITDA was \$515,000 compared to budgeted EBITDA of \$510,000. The April EBITDA margin of 5.9% was lower than the 6.6% budget for the month.
- CSG and CNT revenue of \$3.4 million was favorable to prior year by \$219,000. The variance was attributable to additional contract
 opportunities being awarded.
- CNGS and CNTS generated \$5.2 million was \$1.3 million favorable to budget. The favorable budget variances are due to higher than anticipated contract volume during FY13.
- CSG submitted a proposal to the U.S. Geological Survey Nation for scientific support services for the earth resources observation and science center. This proposal is valued at \$13 million over 5 years.

Operating Highlights

- CNSD net income of \$40,000 was unfavorable to a budgeted net income of \$119,000. EBITDA margin of 2.9% compared to the budget of 5.6% due to decreased activity in CNRW.
- **CNCS** resulted in a net income of \$22,000, which was unfavorable to budgeted net income of \$33,000. The unfavorable variance was due to higher than budgeted overhead employee cost and operating expense.
- Mobility Plus resulted in a net loss of \$71,000 compared to budgeted net income of \$54,000. The budget variance was primarily the result of lower than anticipated revenue of \$176,000.
- **CMS / CNHS** resulted in a net income of \$37,000 compared to budget of \$10,000. Higher revenue and better margins contributed to the favorable budget variance.
- APSE net income of \$8000 in April 2013 compared to a budgeted net loss of \$3,000. Net income exceeded budget primarily due
 increased sales to M7 Aerospace as well as revenue related to a new contract with GreenPoint Technologies.
- <u>CCRC</u> net income of \$122,000 was favorable to a budget of \$102,000. April 2013 revenue was \$2.4 million compared to budget of \$1.3 million. Higher revenue was the result of revenue recognized on the Picatinny construction projects and on the BIA dormitory project.




b. Notable accomplishments:



- 1. Record high lending activity in the commercial loan account; typically we loan \$1 million annually in commercial loans, creating or sustaining 100+ jobs. We expect to loan approximately \$2 million this year, with requests for funding greatly exceeding this number.

- 5. Cherokee Arts Center Gallery, the Spider Gallery, has moved into the Cort Mall Building on Main Street. Over 50 artists are represented in this Gallery and visitors have greatly increased since the move.

. Future plans/new initiatives

1. Artists as Entrepreneurs:

- a. Working with the Bradford Exchange to test the market for a **Cherokee coin series**. Still in discussion stages. Anticipated outcomes of this project are a revenue stream for the Cherokee Arts Center and income for local Cherokee artists.
- b. Entering into discussions with Oklahoma Israel Exchange regarding cultural exchange and commercial marketing distribution channels for Cherokee artists.
- c. Entering discussions with the **Jewish Federation of Tulsa** to discuss marketing distribution channels for Arts Gallery and Cherokee artists.
- 2. Recruiting Cherokee entrepreneurs to lease three retail spaces in the Cort Mall, one retail space will be used for a Coffee Shop/Bistro and one retail space will likely house traveling art exhibits. One potential lessee is an Art Supply store.

3. Entrepreneurship Competitions:

- a. **Youth Entrepreneur Day** will be scheduled for Tahlequah and we are working with Rogers State University Innovation Center to coordinate a second day in the northern counties to encourage more widespread competition.
- b. **Entrepreneurship Competition** for adults is under design. We will be seeking vendor sponsorship for this event and anticipate cash prizes to start or expand a business. This event will be held in conjunction with similar events throughout the state in the fall 2013.

Please note in the commercial account we currently have approximately \$700,000 in available commercial funds and receive approximately \$75,000 in monthly payments. As of June 7, we have approximately 1.2 million in pending loan requests, some of which are likely to be approved in the next month. We will not hear back on the CDFI grant request until the fall and we are unsure when we will hear back on the USDA grant request. If this increased need for small business financing continues, we will likely have to reduce maximum loan amounts and prioritize funding.

Cherokee Heritage Center Report – June, 2013

- Ancient Diligwa Opened on June 3rd. Project has been funded and work is in progress. Word delayed due to weather, but now that rain is over is moving along very well.
- Website has had over 30,000 visitors since Sept. 2012 when it was established, with over 125,000 page views.
- Facebook page has 6,120 friends, and each month reaches over 72,500 people.
- Curator Michael Yantz managed presentations for the NSU Symposium on the American Indian.
- The CHC won the Red Bud Merit Award for Temporary Exhibition in Oklahoma for the Female Seminary Exhibit
- Hosted the Trail of Tears Art Show Sales were up over 9% to \$19,273 over last year. It should be noted that CNB was not a buyer this year.
- The CHC is operating with a staff of 16 compared to 29 in 2010, creating difficulties in achieving day to day and annual goals
- Dr. Charles Foster, who teaches the Cherokee language at the University of Oklahoma as accepted a temporary position to teach Cherokee to staff and visitors at the Adams Corner School house on the CHC Grounds. His position is funded by the Cherokee Heritage Center.
- We have hired 9 (non-staff) villagers with another coming on soon. These seasonal positions are funded by revenue from outreach, genealogy, disbursements from the endowment and unrestricted donations. No Cherokee Nation funds are used to pay these employees.
- The CHC has partnered with Crystal Bridges Museum in Arkansas and the Will Rogers Museum in Claremore. We now have exhibits at both museums.
- Under new leadership, the CHC Board of Trustees are being asked to focus on raising funds for the endowment so that earnings from the endowment fund can provide a greater portion of our funding needs in the future.
 The endowment is currently valued at about \$800,000.00.
- The quarterly Board of Trustees meeting is scheduled for July and all council and administration members are invited and encouraged to attend.
