WHEREAS, Mark Fredrick Green is duly qualified to fill this seat pursuant to Title 63 Section 101 (A) CNCA.

BE IT RESOLVED BY THE CHEROKEE NATION, that Mark Fredrick Green is hereby confirmed as a Commissioner of the Cherokee Nation Environmental Protection Commission for a term from August 2009 to August 2011.
