**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;



**WHEREAS**, Cherokee Nation Sequoyah Schools recognizes the need to be resourceful with out Nation's assets and assist our public schools when possible.




