WHEREAS, the term of office of this Commissioner expires September 2010;

WHEREAS, Jennifer Barger Johnson is duly qualified to fill this vacancy pursuant to Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.

BE IT RESOLVED BY THE CHEROKEE NATION, that Jennifer Barger Johnson is hereby confirmed as a Commissioner of the Cherokee Nation Gaming Commission for the term from January 2009 until September 2010, as authorized by Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.
