APPROVAL OF MINUTES

Councilor Taylor moved to approve the August 11th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb reminded everyone of the sendoff of the World War II Veteran's on their trip to Washington D.C. at the Hard Rock on Monday. She commented they are open to suggestions in regard to the new report layout. Councilor Hargis inquired about remaining clothing vouchers for those who have missed out. Councilor Cowan Watts inquired about the status of the Tulsa/Rogers County Advocate. She questioned the over income tribal burials. She also asked about extending hours at the Collinsville food distribution site. Councilor Keener inquired about the Child Support report by case load. Councilor Fishinghawk inquired if they were going to be prepared to take the Community Youth and Adult Grants on the first of October. Councilor Buzzard inquired if the burial funds for the over income were tribal dollars.

Councilor Coates inquired about the community organizations being moved under the Secretary of State and if we would continue to get reports.
