WHEREAS, Janice Carlile Randall is duly qualified to fill this board position, Seat 1 (one) pursuant to the Bylaws of the Cherokee Nation Foundation;

BE IT RESOLVED BY THE CHEROKEE NATION, that Janice Carlile Randall is hereby confirmed as a Board Member of Cherokee Nation Foundation, Seat 1 (one) for the term February, 2013 expiring February, 2017, as authorized by the Bylaws of Cherokee Nation Foundation.
