WHEREAS, the Cherokee Nation Comprehensive Care Agency was created and authorized as a Tribal Agency by Article V, Section 7 of the Constitution of the Cherokee Nation and Legislative Act #3-04;

WHEREAS, the Principal Chief is authorized by Section 5.E. of LA#3-04 to select the members of the Board subject to confirmation by majority vote of the Council of the Cherokee Nation;

WHEREAS, the initial term of office of Board Members is to be appointed; and Janie Dibble is duly qualified to fill this seat and has been selected by the Principal Chief.

BE IT RESOLVED BY THE CHEROKEE NATION, that Janie Dibble is hereby confirmed as a Governing Board Member of the Cherokee Nation Comprehensive Care Agency for a term of three (3) years, commencing March 2011 until March 2014.
