CALL TO ORDER

Deputy Speaker Easley called the meeting to order at 1:00 p.m.

INVOCATION

Councilor Shotpouch gave the invocation.

ROLL CALL

APPROVAL OF MINUTES

Councilor Deere moved to approve as submitted. Councilor Hall seconded the motion. The motion carried.

REPORTS:

Marshal Service - Daniel Mead

Marshal Mead gave highlights from the report then offered to answer any questions.

Office of the Attorney General - Chad Harsha

Mr. Harsha gave an update on the pending litigation and commented on the recently held jury trials. He offered to answer questions from the report. Councilor Deere requested an update on the Stroble case. Councilor Callison commented on the high praises for the Cherokee Nation Assistant Attorney General in Jay.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin offered to answer questions from the report provided.

Tax Commission - Sharon Slepston

Ms. Neff offered to answer questions in the absence of Ms. Slepston.

Gaming Commission - Audra Imhoff

Ms. Imhoff offered to answer questions from the report. She announced the next board meeting would be held on September 19th at the Hard Rock.

Human Resources - Samantha Hendricks

Ms. Hendricks gave highlights from the report. They continue to move their processes from paper to electronic. She provided an update on the Career Pathways program. She offered to answer questions from the report. Councilor Blackfox-Qualls requested the contact information for the Human Resources Health Director.

OLD BUSINESS

1. **25-057** AN ACT AMENDING TITLE 21 ("CRIMES AND PUNISHMENTS") OF THE CHEROKEE NATION CODE ANNOTATED

Councilor Tehee moved to approve the revised version provided. Councilor Deere seconded the motion. Councilor Coates stated the changes are quite extensive. She offered a friendly amendment to table to allow time to review. Councilor Tehee requested Attorney General Harsha provided an overview of the changes. Following a few additional questions Attorney Young gave additional clarification. Chair Easley inquired if the friendly to table is accepted. Councilor Tehee didn't accept the friendly amendment.

The motion to approve the revised version carried with no opposition.

Councilor Callison seconded the nomination. With no other nomination the motion to select Councilor Kidwell as Speaker carried with the following roll call vote:

Councilor Deere moved to approve. Councilor Callison seconded the motion. Chair Easley opened the floor for nominations. Councilor Blackfox-Qualls nominated Councilor Sam. Councilor Deere seconded the motion. With no other nomination the motion carried unanimously.

11. [TMP-420](#) DISCUSSION AND POSSIBLE ACTION: SELECTION OF TRIBAL COUNCIL COMMITTEE CHAIRS & CO-CHAIRS

Councilor Legg moved to approve. Councilor Callison seconded the motion.

Chair Easley opened the floor for nominations for Rules Committee Chair. Councilor Blackfox-Qualls nominated Councilor Kidwell. Councilor Callison seconded the motion. No other nominations were presented. The motion to approve carried unanimously.

Chair Easley opened the floor for nominations for Rules Committee Co-Chair. Councilor Callison nominated Councilor Easley. Councilor McGeady seconded the motion. No other nominations were presented. The motion to approve carried unanimously.

Chair Easley gave the newly elected Rules Chair the gavel to take over the remainder of the meeting.

Chair Kidwell opened the floor for nominations for Executive & Finance Committee Chair. Councilor Callison nominated Councilor Patzkowski. Councilor Easley seconded the nomination. No other nominations were presented. The motion to approve carried unanimously.

Councilor Easley resigned his position as Co-Chair of Executive & Finance Committee.

Chair Kidwell opened the floor for nominations to fill the now vacated Co-Chair of Executive & Finance Committee. Councilor Patzkowski nominated Councilor Callison. Councilor Easley seconded the motion. No other nominations were made. The motion carried unanimously.

Councilor Legg resigned his position as the Chair of Community Services Committee.

Chair Kidwell opened the floor for nominations to fill the now vacated Chair of Community Service Committee. Councilor Legg nominated Councilor McGeady. Councilor Grant seconded the motion. No other nominations were made. The motion carried unanimously.

Chair Kidwell opened the floor for nominations for Culture Committee Co-Chair. Councilor Legg nominated Councilor Grass. Councilor Tehee seconded the motion. The motion carried unanimously with no other nominations presented.

Chair Kidwell opened the floor for nominations for Resources Committee

Chair. Councilor Shotpouch nominated Councilor Hall. Councilor Grass seconded the motion. The motion carried unanimously with no other nominations presented.

Councilor Hall resigned her position as Co-Chair of Resources Committee.

Chair Kidwell opened the floor for nominations for the now vacant Co-Chair of Resources Committee. Councilor Legg nominated Councilor Hughes.

Councilor Patzkowski seconded the nomination. No other nominations were made. The motion carried unanimously.

Chair Kidwell opened the floor for nominations for Health Committee Chair. Councilor Tehee nominated Councilor Blackfox-Qualls. Councilor Sam seconded the motion. No other nominations were presented. The motion carried unanimously.

Councilor Patzkowski resigned her position as Health Committee Co-Chair.

Chair Kidwell opened the floor for nominations to the now vacant Health Committee Co- Chair position. Councilor Patzkowski nominated Councilor Grant. Councilor McGeady seconded the motion. The motion carried with no opposition.

Chair Kidwell opened the floor for nominations for Education Chair. Councilor Legg nominated Councilor Tehee. Councilor Easley seconded the nomination. The motion carried with no opposition.

Chair Kidwell opened the floor for nomination for the Education Co-Chair. Councilor Tehee nominated Councilor Coates. Councilor Blackfox-Qualls seconded the motion. The motion carried with no other nominees presented and no opposition.

DISCUSSION AND POSSIBLE ACTION: SELECTION OF COUNCIL ADVISORY BOARD MEMBERS

Chair Kidwell opened the floor for the selection of the 4 vacant Housing Authority positions. Councilors Blackfox-Qualls, Tehee, Hall, and Hughes joined Councilor Poindexter to complete the Housing Authority Advisory board along with Councilor Grant as an alternate.

Chair Kidwell opened the floor for the selection of vacant positions for Inter-Tribal. Councilor Patzkowski resigned her position. Councilor Easley resigned as an alternate. Councilors Poindexter, Kidwell, and Grass joined

Councilor Deere along with Councilor Blackfox-Qualls as the alternate.

ANNOUNCEMENTS

Councilor Easley inquired if Speaker Elect Kidwell would like to make any comments. Councilor Easley commented on the selflessness of the new elected Council leadership.

Recording Secretary Coke requested clarification on Business Item #12 stating there wasn't a vote taken after all of the selections were made. Chair Kidwell requests a vote be taken to confirm the selections of all of the advisory boards. The motion carried with no opposition.

ADJOURNMENT

Councilor Deere moved to adjourn. Councilor Patzkowski seconded the motion. The motion carried at 2:37 p.m.
