**BE IT RESOLVED,** that Harold "Sam" Ray Hart, is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors, filling Seat 6 (six) to begin November 11, 2014 and expiring November 30, 2017.
