### CALL TO ORDER

Chair Snell called the meeting to order at 10:10 a.m.

### INVOCATION

Councilor Crittenden gave the invocation.

### ROLL CALL

### APPROVAL OF MINUTES

Councilor Jack Baker made a motion to approve the September 15th regular session minutes. Councilor Crittenden seconded the motion. Motion carried.

### REPORTS:

1. Management Resources - Jack Farmer/Angela Drewes

*Ms. Angela Drewes gave a brief history of how the meetings began at the field locations such as Bull Hollow. She provided a list of Ga Du Gi projects the Natural Resources staff participated in over the last fiscal year. She stated most of these projects are in Delaware and Adair county due to the field office locations and convenience. They are in the process of getting a policy for these projects approved. She announced they would do projects in other counties but the requesting party would have to pay for the fuel to and from the site as well as the equipment fuel used on the job.*

Councilor Bill John Baker made a motion to send a \$20,000 request to Executive and Finance committee for fuel cost on Ga Du Gi projects. Councilor Crittenden seconded the motion.

Councilor Cowan Watts made a motion to table until the policy is complete to determine if the amount suggested is accurate. Councilor Anglen seconded the motion. The motion to table failed with six (6) yeas and six (6) nays as follows:

Councilors Buel Anglen, Jack Baker, Harley Buzzard, Don Garvin, Curtis Snell and Cara Cowan Watts voted yeas to table.

Councilors Bill John Baker, Joe Crittenden, Meredith Frailey, Janelle Fullbright,

Tina Glory-Jordan, and David Thornton voted nay to table.

**After additional discussion to send a \$20,000 request to Executive and Finance Committee for Ga Du Gi project fuel the motion passed with Councilor Cowan Watts opposed.**

1. Management Resources - Jack Farmer/Angela Drewes

*Ms. Angela Drewes announced they continue to meet with CNB and the U. S. Fish and Wildlife Service regarding wind energy and a wildlife study. They have completed a grant proposal for tribal wildlife. She stated they are making effort to identify all of the culturally significant plants that could be used for medicinal or art purposes.*

2. Construction/Facilities Report - Jack Farmer/Angela Drewes

*Mr. Jack Farmer announced as of today they have completed the Markoma boys facility for Health Services.*

2. Real Estate Services - Linda Donelson

*Ms. Linda Donelson announced we have the trust deed on the Complex II. She stated that anyone who lives and or works on trust land doesn't have to pay State income taxes. By the end of October they should receive additional news about the rest of the complex.*

3. Roads & Transportation - Michael Lynn

*Mr. Michael Lynn gave an update on the IRR projects as follows:*

*Barber road - they met with the BIA to discuss a design exception for the portion of the road that will take most of the front yard of a home and a cemetery that is extremely close to the road as well.*

*North East Ft. Gibson - the preliminary plan is ahead of schedule.*

*Rice Woodard Road - in the process of placing bids for the utilities.*

*Cookson Road - the overlay project is near completion.*

*Honey Hill - the project has been broken into 2 phases due to a land owner being on active military status. Condemnation can not be filed on a land owner who has active military status. the first phase is expected to begin in early 2009.*

*Twin Oaks Bull Hollow - the design is near completion.*

*Kenwood road - a meeting is scheduled with the engineer and the commissioner to discuss design plans.*

*Daytown Drycreek - the project is on schedule. They have completed the paving.*

*The continue to have the daily transit route from Stilwell to the complex with an average of five passengers daily. They are in the process of developing a transit route from Pryor to Claremore then on to Catoosa.*

*He announced the green signs that state you are either entering or leaving the Cherokee Nation will change to brown.*

*They have four road projects going to Executive and Finance this month.*
