### A RESOLUTION CONFIRMING THE REAPPOINTMENT OF JOHN SPARKS AS MEMBER OF THE CHEROKEE NATION GAMING COMMISSION

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and


**WHEREAS**, The Principal Chief, as a representative of the Cherokee Nation is authorized to select members of the Cherokee Nation Gaming Commission, subject to the majority vote of the Council of the Cherokee Nation; and,

**WHEREAS**, John Sparks is duly qualified and should be a member of the Cherokee Nation Gaming Commission and its successors.


**BE IT RESOLVED BY THE CHEROKEE NATION**, that John Sparks is hereby confirmed as a member of the Cherokee Nation Gaming Commission, serving a term of (3) three years from November 2019 to November 31, 2022.

### CERTIFICATION




